Japan Credit Rating Agency, Ltd. (JCR) announces the following credit rating.

### Japan Bank for International Cooperation (security code: -)

#### Rationale

- (1) Japan Bank for International Cooperation ("JBIC") is a special company whose shares are wholly owned by the government of Japan. It supports Japanese companies' acquisition and development of natural resource interests, export of infrastructure, overseas M&A deals and so on, in line with the government's external economic policies, etc., through financings, investments, and guarantees. JBIC's statutory law (the "Statutory Law") stipulates that, along with other provisions, the government is obliged to hold all of JBIC's shares and may make additional investments. The funds for financings and investments necessary for JBIC's operations are sourced by the government budget. JBIC's strong legislative ties with the government and extremely high political significance and importance.
- (2) In the financial year ended March 2023 (FY2022), the total of outstanding loans, equity participation and guarantees increased 12.1% year on year to 2.3 trillion yen. Centering on the Global Investment Enhancement Facility, JBIC supported Japanese companies working to preserve the global environment, enhance supply chains and create new markets overseas. In April 2023, the Statutory Law was amended in response to changes in the international situation surrounding the Japanese economy, and thereby the roles of JBIC in implementing Japan's external economic policies became increasingly important. Foreign companies underpinning the supply chains and industrial foundations of Japanese companies were added to the scope of loans. Regarding Special Operations, financings of and investments in resources development and start-ups were also added. In addition, because it became possible for international financial institutions to guarantee loans to Ukraine, JBIC is expected to contribute to Ukraine's reconstruction in terms of financing in cooperation with G7 development finance institutions and other organizations.
- (3) FY2022 net income increased significantly, reaching a record high since its establishment in 2012. Profits were boosted by expanded net interest income due to the yen's depreciation and rises in U.S. interest rates. In addition, JBIC recorded a gain on the reversal of allowance for loan losses, whereas it had made a large increase in the allowance in the previous fiscal year. For the time being, attention should be paid to the possibility that additional credit costs will be incurred with regard to credit extended to Russia. That said, JBIC's Ordinary Operations account is managed in accordance with the certainties of redemption and the principle of ensuring the balance between revenue and expenses based on the Statutory Law. Given that JBIC's fundamental earning capacity is high in light of the fact that appropriate interest rates set on loans considering credit risks, etc., and that JBIC has been remaining in the black since the days of the former JBIC, JCR sees that JBIC will be able to make profits in the medium to long run even if its profit and loss deteriorate in the short term.
- (4) The non-performing loans ratio under the Financial Reconstruction Law had been on increase, but at the end of FY2022, it fell to the upper 2% range with a decrease in loans requiring management. With regard to sovereign debts, the risk of loan loss is limited thanks to a public institutions-specific structure provided by the meetings of creditor countries (the Paris Club). On the other hand, for nonsovereign debts, bad loans and credit costs tend to increase due to fluctuations in the external environment for many large resource-related projects. There is also the possibility that the quality of assets will be deteriorated by heightened geopolitical risks such as the situation in Ukraine. However, JBIC's common equity Tier 1 ratio (non-consolidated) is high at 19.4% at the end of March 2023. The government verifies the size of risks in JBIC and makes additional investments as appropriate. JCR hence believes that JBIC will maintain an adequate level of equity capital against risks associated with financings and investments.

B) Business Bases

The likelihood of a given debt payment is highly conditional to its issuer's business bases - how they can be maintained/ expanded into the future and thereby secure earnings and cash flows in adequacy and in a sustainable way.



C) Financial Grounds and Asset Quality

The likelihood of debt payment is highly dependent on the degree of the issuer's indebtedness and loss absorption capacity in terms of equity capital. Also notable is that a financial institution might see a significant loss of financial grounds as a result of changes in value of the assets under its possession.

D) Liquidity Positions

The likelihood of debt payment is highly dependent on the adequacy of the issuer's cash and other sources of repayment (liquidity positions).

E) Order of Seniority in Debt Payment

The likelihood of debt payment can be different between given debts of the same issuer. The likelihood of debt payment for an individual debt is dependent on the issuer's discretion, and/ or its rank relative to other debts of the same issuer in the order of seniority in principal/ interest payment which is determined by design as financial product or by laws, etc.

The credit rating is subject to alteration if there is a change in the issuer's legal support by the government, personnel or capital relationship with the government, importance in the government's policy, credit enhancement and other forms of the government's supporting policy, framework and the strength thereof. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is large.

B) Business Bases

The credit rating is subject to alteration if there is improvement or deterioration of the issuer's business bases, since its revenue, etc. may improve or deteriorate by the change in its business management policies, clients' preferences, competitive situation, or a technological innovation. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change in the business bases is large.

C) Financial Grounds and Asset Quality

The credit rating is subject to alteration if the issuer increases/ decreases its debt/ capital or vice versa and thereby makes its individual debt payment liability less or more bearable and its loss absorption capacity into the future decreased or increased. Also, the changes in the quality of asset under the



issuer's holding may affect the credit rating, since such changes could raise or lower the likelihood of future loss of the issuer's financial grounds. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change in the financial grounds and/ or asset quality is large.

D) Liquidity Positions

The credit rating is subject to alteration if there is a change in the issuer's financial management policy or in the relations with fund procurement sources and the change thereby makes its liquidity positions improve or deteriorate. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is large.

E) Creditworthiness of the Government, etc. that Constitute the Framework of Credit Enhancement The credit rating is subject to alteration if there is a change in the creditworthiness of the government, etc. that constitute the framework of credit enhancement. The resultant alteration of the credit rating is usually a notch, with possibility of a few notches if and when the change on such framework is exceptionally large.

#### F) Various Events

The credit rating is subject to alteration on occurrence of various events, such as change in the issuer's major shareholders, M&A and other organizational change, accident, violation of the law, litigation, legal/ regulatory change, natural disaster, etc., which are unforeseeable at the time when the credit rating is determined, causing a significant change on the issuer's business bases, financial grounds, etc. The resultant alteration of the credit rating could be by a notch but more often than not as much as a few notches.

The credit rating herewith presented could be changed if and when the assumptions made at the time of its determination turn out to be inaccurate with regard to the issuer's business bases and powers of earning or cash flow generation, etc. The resultant change of the credit rating is most likely by a notch, as JCR speculates, but possibly as much as a few notches if the development is rapid in improvement or deterioration of the issuer's business bases on some drastic change in the operational environments, etc.

#### C) Financial Grounds and Asset Quality

The credit rating herewith presented could be changed if and when the assumptions made at the time of its determination turn out to be inaccurate with regard to the issuer's financial grounds and asset
