ABCP Program: J-1+

### *Rationale*

This is a securitization of credit card monthly clear receivables. The certainty of principal redemption of ABCP based on the ABCP Program is considered to be converted and linked to the creditworthiness of Mizuho Bank, Ltd. providing 100% credit enhancement and liquidity supplement, and thus JCR has affirmed a rating of J-1+ to the ABCP Program.
