Japan Credit Rating Agency, Ltd. (JCR) announces the following credit rating.

Rationale

- (1) Established in 1949, Sumitomo Realty & Development Co., Ltd. (the "Company") is one of Japan's major diversified real estate companies. It mainly operates the Leasing segment. In particular, it owns a number of competitive office buildings, mainly in central Tokyo, thereby establishing a solid business base. It also engages in other segments such as Sales centering on condominiums with the industry's top-class supply track record; Construction for large-scale Shinchiku Sokkurisan remodeling and custom home constructions; and Brokerage. Moreover, as part of the efforts aimed at bringing ordinary income from the overseas business to 30 billion yen in the future, it is developing two offices buildings and carrying out the super high-rise mixed-use urban development project in Mumbai, India.
- (2) The Company will probably be able to keep improving its earnings capacity and cash flow generation capacity as it is now. In particular, it is constantly strengthening the earnings base for office building leasing mainly in central Tokyo, and its performance will likely be driven by the highly stable Leasing segment. Despite aggressive investment in real estate development, the financial structure is improving thanks in part to an increase in cash flow generation capacity, and this direction will likely be maintained into the future. Based on the above, JCR upgraded the Company's long-term issuer rating by one notch to AA and changed the outlook to Stable.
- (3) Operating income for the fiscal year ending March 2024 (FY2023) is projected to rise 5.7% over the year to 255 billion yen, reaching a new high for the second consecutive year. Office leasing in the Leasing segment is robust, and revenues from hotels, event halls, etc. are expected to make full recovery. Moreover, not only earnings from Sales centering on condominiums will remain high, but also Construction and Brokerage will probably achieve earnings growth. JCR assumes that the Company will keep improving operating income in FY2024 and beyond, too.
- (4) Equity ratio and net D/E ratio as of September 30, 2023 were 29.8% and 1.9x, as opposed to 28.3% and 2.1x at March 31, 2023. Financial ratios have improved thanks to the expansion of equity capital with constant profit accumulation. There are also sufficient unrealized gains on assets, providing a financial buffer. Although the Company is likely to keep expanding leasing assets mainly in central Tokyo and making aggressive investments in Mumbai, it can still strengthen its financial base in JCR's view.

The likelihood of a given debt payment is highly conditional to its issuer's business bases - how they can be maintained/ expanded into the future and thereby secure earnings and cash flows in adequacy and in a sustainable way.

B) Financial Grounds and Asset Quality

The likelihood of debt payment is highly dependent on the degree of the issuer's indebtedness and loss absorption capacity in terms of equity capital. Also notable is that a financial institution might see a significant loss of financial grounds as a result of changes in value of the assets under its possession.

C) Liquidity Positions

The likelihood of debt payment is highly dependent on the adequacy of the issuer's cash and other sources of repayment (liquidity positions).

D) Related Parties' Status and Stance of Support/ Assistance for the Issuer

The likelihood of debt payment is affected one way or the other by the issuer's related parties such as parent company, subsidiary, guarantor, and the government of the issuer's business domicile, etc. - by their own conditions and/ or position of support/ assistance for the issuer.

A) Business Bases

The credit rating is subject to alteration if there is improvement or deterioration of the issuer's business bases, since its revenue, etc. may improve or deteriorate by the change in its business management policies, clients' preferences, competitive situation, or a technological innovation. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change in the business bases is large.

B) Financial Grounds and Asset Quality

The credit rating is subject to alteration if the issuer increases/ decreases its debt/ capital or vice versa and thereby makes its individual debt payment liability less or more bearable and its loss absorption capacity into the future decreased or increased. Also, the changes in the quality of asset under the issuer's holding may affect the credit rating, since such changes could raise or lower the likelihood of future loss of the issuer's financial grounds. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change in the financial grounds and/ or asset quality is large.

C) Liquidity Positions

The credit rating is subject to alteration if there is a change in the issuer's financial management policy or in the relations with fund procurement sources and the change thereby makes its liquidity positions improve or deteriorate. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is large.



D) Related Parties' Status and Stance of Support/ Assistance for the Issuer

The credit rating herewith presented could be changed if and when the assumptions made at the time of its determination turn out to be inaccurate with regard to the order of seniority in repayment of interests and principal. JCR assumes the resultant change of the credit rating is most likely by a notch. The change could be as much as a few notches if the issuer's financial structure differs so much and thereby the balance between debts shifted so greatly.
