Japan Credit Rating Agency, Ltd. (JCR) announces the following credit rating.

Ecology Trust Bond 3rd Fund Trust Bonds and Trust ABL

Rationale

This is a project finance where cash flows generated from a number of solar power generation facilities (five power plants in total) are underlying assets. On the back of a favorable amount of solar radiation, the power output has been basically at a good level compared to the initial plan. Meanwhile, the current power output and performance ratio are on the decline due to an increase in the number of output curtailments conducted in 2023. Despite the impact of the power curtailments, its DSCR stays above the assumption and the cash flows from the project is maintained. As JCR does not now confirm any events that would require a material change to the earnings forecast, stress assessments, etc., JCR has affirmed the A- ratings on the trust bonds and trust ABL respectively.
