Japan Credit Rating Agency, Ltd. (JCR) announces the following credit ratings.

Electricité de France S.A. (security code: -)

Rationale

- (1) Electricité de France S.A. (EDF) is an electricity company wholly owned by the French government. The ratings reflect its strong relationship with the government, solid domestic business foundation, strong government support, and efforts to control its net interest-bearing debt. On the other hand, the ratings are constrained by the risk of cost overruns and delays in the construction of nuclear plants as well as the high capital expenditure burdens. The company is expected to maintain a reasonable financial position for the foreseeable future with stable earnings. Based on the above, JCR affirmed the ratings with a Negative outlook. The outlook reflects that of the French government foreign currency long-term issuer rating.
- (2) EDF is mainly engaged in power generation, distribution and retailing, with a high market share in France and operations in overseas countries such as the UK and Italy. It owns and operates the whole nuclear reactors in France and plays a crucial role in the country's energy policy heavily dependent on nuclear power. The government has historically provided capital support to EDF, including capital injections and underwriting of share dividends. Amid the ongoing reassessment of nuclear power from the perspectives of energy security and decarbonization, a framework for government support for the construction of six new EPR2s has been clarified. JCR holds this indicates EDF's relationship with the government and the government's supportive stance will stay stable.
- (3) While cost and schedule management for new nuclear power plant projects remain significant challenges, some progress was seen in 2025. For the domestic six new EPR2 projects, the government support framework has taken shape, including preferential financing covering at least 50% of the construction cost, 40-year Contracts for Difference (CfD), and risk sharing between the government and EDF. Financing for the Sizewell C project in the UK was also ensured. Furthermore, JCR holds that the achievement of 100% power output at Flamanville Unit 3 in December 2025 will help enhance confidence in the EPR technology.
- (4) EDF's EBITDA for the first half of FY2025 was €15.5 billion (€18.7 billion in 1H/FY2024). Its net interest-bearing debt at the end of the period was €50.0 billion (€54.2 billion in 1H/FY2024) for the net interest-bearing debt/EBITDA ratio of 1.5 times. Domestic nuclear power generation for the full year of FY2025 was estimated to have reached 373 TWh, up from the previous year. However, lower electricity prices were seen to have reduced EBITDA by €7-9 billion. JCR estimates EDF retained a certain level of profitability despite a reduced profit. Nuclear power generation is expected to stay stable at around 350-370 TWh from FY2026 to FY2027. While the impact of lower electricity prices will persist, the termination of the ARENH system is expected to positively contribute to earnings, allowing EDF to retain profitability. The company aims to keep its net interest-bearing debt/EBITDA ratio below or equal to 2.5 times up to FY2027.

- The credit rating methodology assumes, in principle, that the factors posted in the below are particularly important for such likelihood to be determined, and that the rating determination is made by evaluating each of them not only quantitatively but also employing qualitative analyses.

A) Legal Protection and Support Provided by the Government

The likelihood of a given debt payment is highly conditional to the issuer's legal protection provided by the government, personnel and capital relationship with the government, importance in the government's policy, credit enhancement, and other forms of the government's supporting policy, framework and the strength thereof.

B) Business Bases

The likelihood of a given debt payment is highly conditional to its issuer's business bases - how they can be maintained/ expanded into the future and thereby secure earnings and cash flows in adequacy and in a sustainable way.

C) Financial Grounds and Asset Quality

The likelihood of debt payment is highly dependent on the degree of the issuer's indebtedness and loss absorption capacity in terms of equity capital. Also notable is that a financial institution might see a significant loss of financial grounds as a result of changes in value of the assets under its possession.

D) Liquidity Positions

The likelihood of debt payment is highly dependent on the adequacy of the issuer's cash and other sources of repayment (liquidity positions).

E) Order of Seniority in Debt Payment

The likelihood of debt payment can be different between given debts of the same issuer. The likelihood of debt payment for an individual debt is dependent on the issuer's discretion, and/ or its rank relative to other debts of the same issuer in the order of seniority in principal/ interest payment which is determined by design as financial product or by laws, etc.

A) Legal Protection and Support Provided by the Government

The credit rating is subject to alteration if there is a change in the issuer's legal support by the government, personnel or capital relationship with the government, importance in the government's policy, credit enhancement and other forms of the government's supporting policy, framework and the strength thereof. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is large.

B) Business Bases

The credit rating is subject to alteration if there is improvement or deterioration of the issuer's business bases, since its revenue, etc. may improve or deteriorate by the change in its business management policies, clients' preferences, competitive situation, or a technological innovation. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change in the business bases is large.

C) Financial Grounds and Asset Quality

The credit rating is subject to alteration if the issuer increases/ decreases its debt/ capital or vice versa and thereby makes its individual debt payment liability less or more bearable and its loss absorption capacity into the future decreased or increased. Also, the changes in the quality of asset under the issuer's holding may affect the credit rating, since such changes could raise or lower the likelihood of future loss of the issuer's financial grounds. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change in the financial grounds and/ or asset quality is large.

D) Liquidity Positions

The credit rating is subject to alteration if there is a change in the issuer's financial management policy or in the relations with fund procurement sources and the change thereby makes its liquidity positions improve or deteriorate. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is large.

E) Order of Seniority in Debt Payment and Non-Payment Forgiven by Contract

The credit rating is subject to alteration if there is a change in the rated debt's status in the order of seniority relative to other debts caused by the improvement/ deterioration of the issuer's financial condition. The resultant alteration of the credit rating is usually a notch, with possibility of a few notches if and when the change is large. Also, in case of the financial products for which non-payment of interest/ principal is contractually permissible, the credit rating is subject to alteration if and when the likelihood of such non-payment is projected to increase or decrease. The resultant alteration of the credit rating could be by a notch but often as much as a few notches.

F) Creditworthiness of the Government, etc. that Constitute the Framework of Credit Enhancement

The credit rating is subject to alteration if there is a change in the creditworthiness of the government, etc. that constitute the framework of credit enhancement. The resultant alteration of the credit rating is usually a notch, with possibility of a few notches if and when the change on such framework is exceptionally large.

G) Rise and Fall in General Economy and Markets

The credit rating is subject to alteration if there is a rise/ fall in the general economy and/ or the markets inducing the issuer's revenues/ expenses to increase/ decrease and vice versa, etc. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is exceptionally large.

The resultant change of the credit rating is most likely by a notch, as JCR speculates, but possibly as much as a few notches if the development is rapid in improvement or deterioration of the issuer's liquidity positions on some drastic change in its financial management policy or relations with fund procurement sources, etc.

E) Creditworthiness of the Government, etc. that Constitute the Framework of Credit Enhancement
