### *Rationale*

- (1) San ju San Financial Group, Inc. ("33FG") is a holding company that was established by business integration between The Mie Bank, Ltd. ("Mie Bank") and The Daisan Bank, Ltd. ("Daisan Bank"), (the "2 subsidiary banks" collectively). While its head office is located in Matsusaka City, Mie Prefecture, it is headquartered in Yokkaichi City, Mie Prefecture. Upon establishment, class 1 preferred stock issued by 33FG was allocated for class A preferred stock that has been issued by Daisan Bank. Similarly, Daisan Bank's 1st series subordinated convertible bonds with 120% call option were transferred to 33FG. The daily average loan balance of the 2 subsidiary banks combined reached as much as 2.6 trillion yen, which is almost equivalent to that of The Hyakugo Bank, Ltd., which is the largest regional bank in Mie Prefecture.
- (2) The 2 banks' ROA combined based on core net business income for the first half of the fiscal year ended March 2018 (FY2017) was slightly low at around 0.25%, but this indicator has been firm. The combined non-performing loans ratio under the Financial Reconstruction Act was also low at around 1.5%. Meanwhile, there is room for improvement in the consolidated core capital ratio after adjustments for general allowance for loan losses, public funds, etc. JCR considers the overall creditworthiness of 33FG as equivalent to A-, taking into consideration the expected enhancement of business base through business integration, a certain earnings capacity and loan assets quality. 33FG owns 100% of shares in the 2 subsidiary banks and all of its board members concurrently serve as board members of the 2 subsidiary banks (excluding members such as audit committee members). Given that 33FG assumes a core role in the group management including formulation of business strategies and risk management, JCR sees that the Group's integrity is strong. In addition, JCR sees that there will be no specific problems with cash flow balance and double leverage ratio of 33FG on an unconsolidated basis and that it is therefore unnecessary to reflect structurally subordinated nature of a holding company to its subsidiaries in rating for 33FG. JCR therefore decided A- rating for 33FG, the same rating for the Group's overall creditworthiness. Having similar level of assets and revenue sizes, Mie Bank and Daisan Bank each is positioned as a core bank of the Group. JCR downgraded rating for Mie Bank by 1 notch to A- in consideration of the Group's creditworthiness, while JCR upgraded rating for Daisan Bank by 1 notch to the same A- in consideration of the Group's credit enhancement.
- (3) While Mie Bank has strength in northern part of Mie Prefecture centering on Yokkaichi City where its head office is placed, Daisan Bank has strength in middle and southern parts of Me Prefecture centering on Matsusaka City. 33FG plans to increase synergistic effects under the medium-term management plan through mutual utilization of customer bases and know-how in lending and fee

business of the 2 subsidiary banks. The 2 subsidiary banks are expected to be merged, which JCR considers will lead to more efficient office network and increasing sales staff. They are studying to integrate their core systems toward merger. JCR will closely watch whether the integration may have excessive impact on expenses. The core net business income of the 2 subsidiary banks combined (excluding gains on cancellation of investment trusts) has been solid in the face of tough business environment where many regional financial institutions worsened their earnings capacity. JCR sees that the Group's earnings capacity will be strengthened through synergies derived from the business integration.

- (4) It is highly likely that a recording of gain on negative goodwill due to the business integration will push up 33FG's consolidated core capital ratio. Even with such contributions, there remains room for improvement of the adjusted consolidated core capital ratio in comparison with regional financial institutions having A category ratings. JCR considers that the risk assets will continue to rise with an increase of loans in the local area and that it will be important in terms of rating whether it can improve the core capital ratio on an ongoing basis through enhancement of earnings capacity.
- (5) Mie Bank is a regional bank with a fund volume of approximately 1.7 trillion yen. Although its core net business income and ROA were slightly low for the first half of FY2017, which stood at 2.1 billion yen and round 0.2%, respectively, these indicators have been recovering since FY2016. Given the low yield on loans, JCR sees that the improvement is an issue facing Mie Bank. However, it has succeeded in mitigating the declining pace of the yield on loans through reduction in loans to large corporations and growing loans to SMEs with relatively higher yields. Its net interest income began to increase thanks partly to a decline of the financing cost. Fee business, on which it focuses its attention, is increasing its contributions to revenue thanks to the expansion of handling of derivatives for corporate customers. With low securities-to-deposit ratio, interest rate risk amount due to the bond holding is controlled against capital level. Although price fluctuation risk from stock and investment trusts is relatively large against capital level, unrealized gains on securities work as a buffer against risks. Its non-performing loans ratio under the Financial Reconstruction Act was low at 1.23% as of December 31, 2017 and its credit costs have been low and stable. The adjusted consolidated core capital ratio was in the lower 8% range as of September 30, 2017, slightly lower than the previous level of around 8.5%. In light of elements such as asset quality, JCR values that this ratio is at a decent level. JCR sees, however, that it will continue increase taking credit risks and others.
- (6) Daisan Bank is a second-tier regional bank with a fund volume of approximately 1.7 trillion yen. Its core net business income and ROA were 2.6 billion yen and around 0.25% for the first half of FY2017. Daisan Bank retained roughly the same levels for these figures as those for FY2016. Despite the retention of average yield on loans among second-tier regional banks, the yield has been declining. Further mitigation of the declining pace of the yield through measures such as augmentation of loans in Mie Prefecture with relatively high yield is an issue facing Daisan Bank. Its net interest income began to increase thanks to a decline of the financing cost and an increase of interest and dividend on securities. Although its net fees and commissions declined due to a decrease of insurance sales income as a result of changes to the receiving method of commissions as a primary reason and increased services cost, the fee income has been at a high level. Through focus on corporate fee business, it has achieved a certain good result. JCR will pay attention to how much it can increase its income through measures such as use of Mie Bank's know how. For the securities investments, it is increasing equity investment trusts with relatively high yield. For this reason, unrealized gains on securities are working as a risk buffer. However, price fluctuation risk from stock and investment trusts is large against capital level. Its non-performing loans ratio under the Financial Reconstruction Act was low at 2.06% as of December 31, 2017. Although a certain level of credit costs will be incurred in light of no small loans to customers with middle risks, JCR sees that it will fully cover the credit costs by the core net business income. There is room for improvement of the adjusted consolidated core capital ratio, which stood at a little more than 5% as of September 31, 2017.

- The credit rating methodology assumes, in principle, to be applied to assess the likelihood of a given debt payment in light of its issuer's condition and business environment, etc. in the relevant future. There is certain limitation, however, in the time horizon that the rating foresees.
- The credit rating methodology assumes, in principle, that the factors posted in the below are particularly important for such likelihood to be determined, and that the rating determination is made by evaluating each of them not only quantitatively but also employing qualitative analyses.

**A) Business Bases**

The likelihood of a given debt payment is highly conditional to its issuer's business bases - how they can be maintained/ expanded into the future and thereby secure earnings and cash flows in adequacy and in a sustainable way.

**B) Financial Grounds and Asset Quality**

The likelihood of debt payment is highly dependent on the degree of the issuer's indebtedness and loss absorption capacity in terms of equity capital. Also notable is that a financial institution might see a significant loss of financial grounds as a result of changes in value of the assets under its possession.

**C) Liquidity Positions**

The likelihood of debt payment is highly dependent on the adequacy of the issuer's cash and other sources of repayment (liquidity positions).

D) Related Parties' Status and Stance of Support/ Assistance for the Issuer

The likelihood of debt payment is affected one way or the other by the issuer's related parties such as parent company, subsidiary, guarantor, and the government of the issuer's business domicile, etc. - by their own conditions and/ or position of support/ assistance for the issuer.

E) Order of Seniority in Debt Payment

The likelihood of debt payment can be different between given debts of the same issuer. The likelihood of debt payment for an individual debt is dependent on the issuer's discretion, and/ or its rank relative to other debts of the same issuer in the order of seniority in principal/ interest payment which is determined by design as financial product or by laws, etc.

### A) Business Bases

The credit rating is subject to alteration if there is improvement or deterioration of the issuer's business bases, since its revenue, etc. may improve or deteriorate by the change in its business management policies, clients' preferences, competitive situation, or a technological innovation. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change in the business bases is large.

### B) Financial Grounds and Asset Quality

The credit rating is subject to alteration if the issuer increases/ decreases its debt/ capital or vice versa and thereby makes its individual debt payment liability less or more bearable and its loss absorption capacity into the future decreased or increased. Also, the changes in the quality of asset under the issuer's holding may affect the credit rating, since such changes could raise or lower the likelihood of future loss of the issuer's financial grounds. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change in the financial grounds and/ or asset quality is large.

### C) Liquidity Positions

The credit rating is subject to alteration if there is a change in the issuer's financial management policy or in the relations with fund procurement sources and the change thereby makes its liquidity positions improve or deteriorate. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is large.

### D) Related Parties' Status and Stance of Support/ Assistance for the Issuer

The credit rating is subject to alteration if there is a change in the issuer's parent company or subsidiary, guarantor or other provider of credit enhancement, or the government of the issuer's

business domicile, or other related parties' own conditions and/ or position of support/ assistance for the issuer, and the change thereby makes its business bases, financial grounds and/ or liquidity positions improve or deteriorate, and/ or making the effectiveness of guarantee and other credit enhancement improve or deteriorate. The resultant alteration of the credit rating is usually a notch, with possibility of a few notches if and when the change is large.

E) Order of Seniority in Debt Payment and Non-Payment Forgiven by Contract

The credit rating is subject to alteration if there is a change in the rated debt's status in the order of seniority relative to other debts caused by the improvement/ deterioration of the issuer's financial condition. The resultant alteration of the credit rating is usually a notch, with possibility of a few notches if and when the change is large. Also, in case of the financial products for which non-payment of interest/ principal is contractually permissible, the credit rating is subject to alteration if and when the likelihood of such non-payment is projected to increase or decrease. The resultant alteration of the credit rating could be by a notch but often as much as a few notches.

F) Rise and Fall in General Economy and Markets

The credit rating is subject to alteration if there is a rise/ fall in the general economy and/ or the markets inducing the issuer's revenues/ expenses to increase/ decrease and vice versa, etc. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is exceptionally large.

G) Various Events

The credit rating is subject to alteration on occurrence of various events, such as change in the issuer's major shareholders, M&A and other organizational change, accident, violation of the law, litigation, legal/ regulatory change, natural disaster, etc., which are unforeseeable at the time when the credit rating is determined, causing a significant change on the issuer's business bases, financial grounds, etc. The resultant alteration of the credit rating could be by a notch but more often than not as much as a few notches.

A) Business Bases

The credit rating herewith presented could be changed if and when the assumptions made at the time of its determination turn out to be inaccurate with regard to the issuer's business bases and powers of earning or cash flow generation, etc. The resultant change of the credit rating is most likely by a notch, as JCR speculates, but possibly as much as a few notches if the development is rapid in improvement or deterioration of the issuer's business bases on some drastic change in the operational environments, etc.

B) Financial Grounds and Asset Quality

The credit rating herewith presented could be changed if and when the assumptions made at the time of its determination turn out to be inaccurate with regard to the issuer's financial grounds and asset quality. The resultant change of the credit rating is most likely by a notch, as JCR speculates, but possibly as much as a few notches if the development is rapid in improvement or deterioration of the issuer's financial grounds and/ or asset quality on some drastic change in its business bases.

C) Liquidity Risks

The credit rating herewith presented could be changed if and when the assumptions made at the time of its determination turn out to be inaccurate with regard to the issuer's liquidity positions. The resultant change of the credit rating is most likely by a notch, as JCR speculates, but possibly as much as a few notches if the development is rapid in improvement or deterioration of the issuer's liquidity positions on some drastic change in its financial management policy or relations with fund procurement sources, etc.

D) Related Parties' Status and Stance of Support/ Assistance for the Issuer

The credit rating herewith presented could be changed if and when the assumptions made at the time of its determination turn out to be inaccurate with regard to the issuer's parent company or subsidiaries, guarantor or other providers of credit enhancement, the government of the issuer's business domicile or other related parties' status and stance of support/ assistance for the issuer. The resultant change of the credit rating is most likely by a notch, as JCR speculates, but possibly as much as a few notches if there is a major change on the part of related parties, such as replacement, disappearance, some drastic improvement/ deterioration of financial grounds/ balances, etc.

E) Order of Seniority in Debt Payment and Non-Payment Forgiven by Contract

The credit rating herewith presented could be changed if and when the assumptions made at the time of its determination turn out to be inaccurate with regard to the order of seniority in repayment of interests and principal. JCR assumes the resultant change of the credit rating is most likely by a notch. The change could be as much as a few notches if the issuer's financial structure differs so much and thereby the balance between debts shifted so greatly. Rating change is also possible in case of the financial products for which non-payment of interest/ principal is contractually permissible, if and when the assumptions made at the time of its determination turns out to be inaccurate. The change of the credit rating is assumed to be by a notch but often as much as a few notches.

D) Related Parties' Status and Stance of Support/ Assistance for the Issuer

The credit rating herewith presented could be changed if and when the assumptions made at the time of its determination turn out to be inaccurate with regard to the issuer's parent company or subsidiaries, guarantor or other providers of credit enhancement, the government of the issuer's business domicile or other related parties' status and stance of support/ assistance for the issuer. The resultant change of the credit rating is most likely by a notch, as JCR speculates, but possibly as much as a few notches if there is a major change on the part of related parties, such as replacement, disappearance, some drastic improvement/ deterioration of financial grounds/ balances, etc.

E) Order of Seniority in Debt Payment and Non-Payment Forgiven by Contract

The credit rating herewith presented could be changed if and when the assumptions made at the time of its determination turn out to be inaccurate with regard to the order of seniority in repayment of interests and principal. JCR assumes the resultant change of the credit rating is most likely by a notch. The change could be as much as a few notches if the issuer's financial structure differs so much and thereby the balance between debts shifted so greatly. Rating change is also possible in case of the financial products for which non-payment of interest/ principal is contractually permissible, if and when the assumptions made at the time of its determination turns out to be inaccurate. The change of the credit rating is assumed to be by a notch but often as much as a few notches.
