Rationale

- (1) Poland is the largest economy in Central and Eastern Europe (CEE) with a nominal GDP of approximately USD1 trillion and a population of around 37 million in 2025. The ratings primarily reflect the country's relatively developed economic base and solid external liquidity. In recent years, the economic growth rate has remained high among EU member states, with real GDP growth reaching 3.6% in 2025. Although the fiscal deficit is on an expanding trend and the government debt is expected to reach a level higher than 70% of GDP by 2028, JCR holds that certain increase of the fiscal burdens can be tolerated as part of the rising debt will be financed through long-term loans provided by the EU. Based on the above, JCR has affirmed the ratings with a Stable outlook.
- (2) The Polish economy is relatively developed with its per capita GDP estimated at around USD52,000 (in ppp terms) in 2024. In 2025, its real GDP growth accelerated to 3.6% from 3.0% in 2024, supported by resilient private consumption driven by rising real wages against the backdrop of a robust labor market as well as an expansion in capital investment financed through EU funds. JCR expects that utilization of the Recovery and Resilience Facility (RRF), whose disbursement deadline comes at the end of 2026, will substantially contribute to capital investment, resulting in the economic growth rate for 2026 remaining at the same level as in 2025. In terms of monetary policy, the central bank resumed rate cuts in May 2025 in response to slowing inflation and implemented a total reduction of 200 basis points by March 2026.
- (3) Poland has been subject to the Excessive Deficit Procedure (EDP) since July 2024 and has been working to improve its fiscal position under EU supervision. Nevertheless, the general government fiscal deficit (ESA 2010) has continued to widen. The deficit was estimated to have deteriorated to 6.9% of GDP in 2025 due to rising defense expenditures, increased spending on public-sector wages and child allowances, and a sluggish tax revenue growth caused by slowing inflation. The government anticipates an increase in tax revenues in 2026 from a higher goods tax and an additional corporate tax on banks. However, expenditures, particularly defense-related outlays, are expected to rise further, and the fiscal deficit is projected to remain higher at 6.5% of GDP. The government debt-to-GDP ratio, assumed to be 59.8% in 2025, is expected to continue rising and may reach the 70% range by 2028. Nevertheless, JCR considers that the impact of the increasing fiscal burden will be partially mitigated, as a portion of the additional borrowing is expected to be financed through EU's low-interest, long-term lending programs, including SAFE (Security Action for Europe) and RRF loans. The government projects that the fiscal deficit-GDP ratio will improve to the 4% range in 2029. However, achieving this will hinge not only on a steady implementation of measures to increase tax revenues but also on whether the growth of net expenditure, used as the fiscal policy benchmark under the EDP, can be contained within the levels recommended by the EU Council. At present, the application of the National Escape Clause (NEC) allows for an increase in defense expenditure of up to 1.5% of GDP, which is expected to prevent deviations from the EU's recommended thresholds. However, as the NEC is a temporary measure in effect only until 2028, close attention will be required regarding its compliance over the medium to long term.
- (4) The country's current account balance recorded a modest deficit of 0.7% of GDP in 2025. While the economies of its trading partners were stagnant, Poland's domestic demand was strong, and the trade balance turned to a deficit as imports grew faster than exports. Capital inflows through direct investment remain strong, helping to retain the country's solid external liquidity. Moreover, its net external debt in IIP terms is on the downtrend. The Polish financial system stays stable. The banking sector is posting stable profits, its nonperforming loan ratio is on a downward trend, and its capital

adequacy ratio is at a sufficient level. Although losses on Swiss franc-denominated housing loans may increase in the future, banks have already increased their provisions and have the capacity to absorb additional costs to a certain extent with their solid profits. Therefore, JCR sees little possibility of a situation where the stability of the financial system can be seriously impaired.

- The credit rating methodology assumes, in principle, to be applied to assess the likelihood of a given debt payment in light of its issuer's condition and business environment, etc. in the relevant future. There is certain limitation, however, in the time horizon that the rating foresees.
- The credit rating methodology assumes, in principle, that the factors posted in the below are particularly important for such likelihood to be determined, and that the rating determination is made by evaluating each of them not only quantitatively but also employing qualitative analyses.

A) Economic Base

The likelihood of a given debt payment is highly conditional to the issuing government's ability to maintain/expand the economic base into the future with maintaining soundness of financial systems.

B) Fiscal Base

The likelihood of a given debt payment is highly correlated to fiscal balance, public debt and other factors of the issuing government's fiscal condition.

C) External Positions

The likelihood of a given debt payment is highly correlated to the liquidity positions which change along with the international balance of payments and the international investment position.

D) Social and Political Bases and Economic Policy

The likelihood of a given debt payment is highly conditional to the social and political stability, effectiveness of economic and monetary policies as well as international economics.

E) Related Parties' Stance of Support/ Assistance for the Government

The likelihood of a given debt payment is affected by the stance of the credit enhancement provider and other related parties with regard to their stance of support/ assistance for the issuing government.

F) Order of Seniority in Debt Payment

The likelihood of debt payment can be different between given debts of the same issuer. The likelihood of debt payment for an individual debt is dependent on the issuing government's will, and/ or its rank relative to other debts of the same government in the order of seniority in principal/ interest payment which is determined by design as financial product or by international practice, etc.
