Japan Credit Rating Agency, Ltd. (JCR) announces the following credit ratings.

Rationale

- (1) Thailand is a constitutional monarchy located in the central part of Indochina and the northern part of the Malay Peninsula. The ratings mainly reflect the country's strong economic fundamentals, particularly its export industry, the stability of its financial system and its resilience to external shocks. The economy has been recovering since 2021 and is expected to maintain moderate growth in 2024, supported by services exports and private consumption. In the longer term, however, economic growth may slow down due to factors such as the falling birthrate and ageing population. Based on the above, JCR has affirmed the ratings with a Stable outlook.
- (2) The Thai government has long been actively using tax incentives to attract foreign companies. It has also focused on infrastructure development in priority areas such as the Eastern Economic Corridor (EEC), and has established itself as a supply chain hub for the automotive, electrical and electronic industries in the Southeast Asian region. The country is highly dependent on trade, with imports and exports of goods and services each accounting for around 65% of GDP (in 2023), making it susceptible to the global economy. Real GDP moderately grew by1.9% in 2023. Private consumption and private investment drove economic growth, with service exports making contribution on recovery of foreign tourists. On the other hand, merchandise exports made a negative contribution due to the economic slowdown in the export destinations. The government has set the growth forecast for 2024 at 2.2-3.2%, assuming a recovery of merchandise exports, expansion of both private consumption and private investment, and a continued recovery of the tourism sector.
- (3) The government had maintained a good fiscal position, although it was forced to expand its public finances significantly in FY2020 (Oct 2019-Sep 2020) due to the impact of the infection spread. In 2021, the public debt ceiling was raised from 60% to 70% of GDP. The public debt-GDP ratio stood at 62.4% of GDP at the end of FY2023. Although uncertainties remain, such as the discussion about the government's planned digital currency handout program, JCR expects the government to keep the public debt-GDP ratio below the 70% ceiling. The public debt, such as government bonds, is mainly held by domestic investors and the ratio of external debt to the public debt is low at 1.4%.
- (4) The current account balance returned to surplus in 2023. Factors that caused the current account deficit in 2021 and 2022, such as high fuel prices and a decline in foreign tourists, are being resolved and the current account surplus is expected to be maintained in 2024. The country's foreign exchange reserves remain large enough in comparison with its imports and short-term external debt. As the banking sector's NPL ratio remains low at 2.7% and its capital base is strong, concerns about the financial system remain low. With household debt in Thailand high at around 87% of GDP, there is pressure on the policy rate to be lowered as a stimulus measure. While an early interest rate cut in the face of high U.S. Fed rates could lead to an outflow of international capital, the country's resilience to external shocks is expected to be maintained.

• The credit rating methodology assumes, in principle, to be applied to assess the likelihood of a given debt payment in light of its issuer's condition and business environment, etc. in the relevant future. There is certain limitation, however, in the time horizon that the rating foresees.

• The credit rating methodology assumes, in principle, that the factors posted in the below are particularly important for such likelihood to be determined, and that the rating determination is made by evaluating each of them not only quantitatively but also employing qualitative analyses.

A) Economic Base

The likelihood of a given debt payment is highly conditional to the issuing government's ability to maintain/expand the economic base into the future with maintaining soundness of financial systems.

B) Fiscal Base

The likelihood of a given debt payment is highly correlated to fiscal balance, public debt and other factors of the issuing government's fiscal condition.

C) External Positions

The likelihood of a given debt payment is highly correlated to the liquidity positions which change along with the international balance of payments and the international investment position.



D) Social and Political Bases and Economic Policy

The likelihood of a given debt payment is highly conditional to the social and political stability, effectiveness of economic and monetary policies as well as international economics.

E) Related Parties' Stance of Support/ Assistance for the Government

The likelihood of a given debt payment is affected by the stance of the credit enhancement provider and other related parties with regard to their stance of support/ assistance for the issuing government.

F) Order of Seniority in Debt Payment

The likelihood of debt payment can be different between given debts of the same issuer. The likelihood of debt payment for an individual debt is dependent on the issuing government's will, and/ or its rank relative to other debts of the same government in the order of seniority in principal/ interest payment which is determined by design as financial product or by international practice, etc.

The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is large.

C) External Positions

The credit rating is subject to alteration if there is a change in the issuer's international balance of payments and international investment position and thereby an improvement/ deterioration of its liquidity positions. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is large.



D) Social and Political Bases and Economic Policy

The credit rating is subject to alteration if there is a change in the issuer's social and political conditions or economic/ monetary policies, etc. and thereby an improvement/ deterioration of its economy and fiscal positions. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is large.

E) Related Parties' Stance of Support/ Assistance for the Issuer

The credit rating is subject to alteration if there is a change in the credit enhancement provider or other related parties with regard to their stance of support/ assistance for the issuing government and thereby an improvement/ deterioration of its economy, fiscal positions and liquidity positions. The resultant alteration of the credit rating is usually a notch, with possibility of a few notches if and when the change is large.

F) Order of Seniority in Debt Payment

The credit rating is subject to alteration if there is a change in the rated debt's status in the order of seniority relative to other debts, due to improvement/ deterioration of the issuer's fiscal condition and/or will. The resultant alteration of the credit rating is usually a notch, with possibility of a few notches if and when the change is large.

G) International Economies

The credit rating is subject to alteration if there is a change in the international economies, commodity or foreign exchange markets, etc. and thereby, through international balance of payments, an improvement/ deterioration in the issuer's fiscal balance or debt payment capacity. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is exceptionally large.

H) Various Events


