Japan Credit Rating Agency, Ltd. (JCR) announces the following credit rating.

#### Rationale

- (1) The ratings are mainly supported by the country's sound fiscal position, solid economic base and stable financial system. The economy and employment have already recovered to pre-COVID-19 pandemic levels by the beginning of 2021 due to the relatively contained pandemic, swift measures to combat with the pandemic and large-scale economic package by the government, and accommodative monetary policies pursued by the Central Bank. The government plans to promote fiscal consolidation after regaining steadily economic recovery supported by the continued economic package. Although the fiscal balance and government debt have deteriorated significantly, the ratio of government debt to GDP remains low, and it has the capacity to absorb the additional fiscal burden. Based on the above, JCR has kept the ratings unchanged with Stable outlook.
- (2) Endowed with rich natural resources such as iron ore, Australia is a highly developed economy with its per capita GDP (in ppp terms) standing over USD 50,000. Supported mainly by the high annual population growth rate of over 1% and the expansion of resource exports, the average annual economic growth rate for the past five years to 2019 was 2.4%. The economic growth rate in 2020 fell by only 2.4%, relatively moderate contraction compared with other advanced economies. The economic impact of worsening relations with China, which accounts for around 40% of goods exports, has been limited so far, and exports remains high level. Although economic activity was contained on the resurgence of the pandemic in 2021, it is expected to recover to around 4% on the rollout of vaccination and the effects of economic package. JCR expects growth of about 2% to 3% in the medium term, but in the long term, measures to cope with decarbonization are necessary. The federal government has recently set to the country's carbon neutral by 2050 and plans to achieve it by promoting investment in low-emissions technology. JCR will pay close attention to how it evolve.
- (3) Australia's chronic current account deficits has turned into a surplus from 2019 on the expansion of exports of iron ore and other products. Although demand for iron ore will shrink in developed countries on the decarbonization, it is highly likely that the current account surplus will continue for the time being as demand continues to grow, especially in Asia. The ratio of net external debt balance to GDP has moderately shrunk due mainly to the continued current account surplus. The country's financial system has been stable as evidenced by solid capitalization of banks and stable profitability. The impact of rising property prices needs to be seen, but additional credit costs resulted from the effect of the pandemic can be absorbed by the stable profitability.
- (4) The government debt has risen sharply as percentage of GDP on the adoption of large scale economic package, but it stays relatively low among the sovereigns rated AAA by JCR. The underlying general government fiscal balance in FY2020/21 (July 2020-June 2021) widened to 7.8% of GDP from 4.3% the year earlier on the continued large-scale economic package and reduced tax revenues on the economic deterioration. The general government debt was below 50% of GDP at the end of 2019, but has risen to nearly 60% at the end of 2020 on the increased fiscal deficit. Since the government plans to promote fiscal consolidation after achieving a sustainable economic recovery, the fiscal deficit will continue for the time being, but there is room for sufficient absorption of the deficit.

  - A) Economic Base

The likelihood of a given debt payment is highly conditional to the issuing government's ability to maintain/expand the economic base into the future with maintaining soundness of financial systems.

B) Fiscal Base

The likelihood of a given debt payment is highly correlated to fiscal balance, public debt and other factors of the issuing government's fiscal condition.

C) External Positions

The likelihood of a given debt payment is highly correlated to the liquidity positions which change along with the international balance of payments and the international investment position.



- D) Social and Political Bases and Economic Policy The likelihood of a given debt payment is highly conditional to the social and political stability, effectiveness of economic and monetary policies as well as international economics.
- E) Related Parties' Stance of Support/ Assistance for the Government The likelihood of a given debt payment is affected by the stance of the credit enhancement provider and other related parties with regard to their stance of support/ assistance for the issuing government.

#### F) Order of Seniority in Debt Payment

The likelihood of debt payment can be different between given debts of the same issuer. The likelihood of debt payment for an individual debt is dependent on the issuing government's will, and/ or its rank relative to other debts of the same government in the order of seniority in principal/ interest payment which is determined by design as financial product or by international practice, etc.

The credit rating is subject to alteration if there is an improvement or deterioration of the issuer's economy or financial systems, etc. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is large.

B) Fiscal Base

The credit rating is subject to alteration if the issuer increases/ decreases its fiscal deficit/ surplus and its public debt and thereby makes given debt payment liability less/ more bearable. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is large.

C) External Positions

The credit rating is subject to alteration if there is a change in the issuer's international balance of payments and international investment position and thereby an improvement/ deterioration of its liquidity positions. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is large.



D) Social and Political Bases and Economic Policy

The credit rating is subject to alteration if there is a change in the issuer's social and political conditions or economic/ monetary policies, etc. and thereby an improvement/ deterioration of its economy and fiscal positions. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is large.

E) Related Parties' Stance of Support/ Assistance for the Issuer

The credit rating is subject to alteration if there is a change in the credit enhancement provider or other related parties with regard to their stance of support/ assistance for the issuing government and thereby an improvement/ deterioration of its economy, fiscal positions and liquidity positions. The resultant alteration of the credit rating is usually a notch, with possibility of a few notches if and when the change is large.

F) Order of Seniority in Debt Payment

The credit rating is subject to alteration if there is a change in the rated debt's status in the order of seniority relative to other debts, due to improvement/ deterioration of the issuer's fiscal condition and/or will. The resultant alteration of the credit rating is usually a notch, with possibility of a few notches if and when the change is large.

G) International Economies

The credit rating is subject to alteration if there is a change in the international economies, commodity or foreign exchange markets, etc. and thereby, through international balance of payments, an improvement/ deterioration in the issuer's fiscal balance or debt payment capacity. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is exceptionally large.

H) Various Events

The credit rating is subject to alteration on occurrence of various events, such as domestic unrest, war, natural disaster, etc. which are unforeseeable at the time when the credit rating is determined, causing a significant change on the issuer's economy, fiscal positions, etc. The resultant alteration of the credit rating could be by a notch but more often than not as much as a few notches.


