Japan Credit Rating Agency, Ltd. (JCR) announces the following credit rating.

RICOH LEASING COMPANY, LTD. (security code: 8566)

<Affirmation>

Rationale

- (1) RICOH LEASING COMPANY, LTD. (the "Company") is a leasing company belonging to the Ricoh Group (the "Group") and an equity-method affiliate of RICOH COMPANY, LTD. ("RICOH") and MIZUHO Leasing Company, Limited ("MIZUHO Leasing"). It has strength in the small-amount lease and installment sales for SMEs. Transactions through distribution channels of the Group's sales companies and distributors account for approximately 40% of the transaction volume of lease and installment sales. The ratings reflect the Company's standalone creditworthiness demonstrated by sound assets, high capital adequacy, stable earning capacity, etc. The key to the rating decisions is whether the Company can improve the profit level with the diversification of earnings sources while maintaining financial soundness.
- (2) The Company has a good customer base and makes transactions with around 400,000 companies centering on SMEs. Under the medium-term management plan launched in April 2023, it aims at constant profit growth by, for instance, investing resources in the areas like the environment, real estate and rental, where there are greater business opportunities, while increasing the efficiency of existing businesses such as leasing. It also intends to continue active investment in human resources, IT infrastructure, etc. as it did under the previous plan. JCR will closely watch whether strengthening collaboration with RICOH and MIZUHO Leasing, as well as the above efforts, will lead to the expansion of the earnings base.
- (3) Earnings capacity is stable. Although there no longer is special rental demand related to COVID-19, new transactions volume has turned around for lease and installment sales. Welfare Suzuran Co., Ltd., which operates nursing care facilities and retirement homes and became the Company's subsidiary in December 2022, is also contributing to overall performance. As the Company has taken profitability-oriented initiatives, bond yields continue to improve. While SG&A expenses are expected to remain high partly because of strategic investments and higher financing costs, the Company's performance will likely remain strong for a while. ROA based on ordinary profit is around 1.5%, which is good in comparison to major leasing companies, and JCR predicts that the Company can maintain high profitability going forward, too.
- (4) Assets present no particular concerns. Their soundness is maintained, backed by the portfolio that is well-diversified into small amounts and also by conservative credit decisions, receivables management and provisioning policy. Even though some large borrowers filed a petition to commence civil rehabilitation proceedings, appropriate provisions had already been made. Capital adequacy is good. Equity ratio as of September 30, 2023 was 17.6%, which is high among leasing companies. It will likely remain almost flat for a while despite the aggressive shareholder return policy. As the Company has diverse financing bases, including corporate bonds and CP, in addition to indirect financing from a number of financial institutions, JCR finds no particular concerns about liquidity.

A) Business Bases

The likelihood of a given debt payment is highly conditional to its issuer's business bases - how they can be maintained/ expanded into the future and thereby secure earnings and cash flows in adequacy and in a sustainable way.

B) Financial Grounds and Asset Quality

The likelihood of debt payment is highly dependent on the degree of the issuer's indebtedness and loss absorption capacity in terms of equity capital. Also notable is that a financial institution might see a significant loss of financial grounds as a result of changes in value of the assets under its possession.

C) Liquidity Positions

The likelihood of debt payment is highly dependent on the adequacy of the issuer's cash and other sources of repayment (liquidity positions).



- D) Related Parties' Status and Stance of Support/ Assistance for the Issuer
 - The likelihood of debt payment is affected one way or the other by the issuer's related parties such as parent company, subsidiary, guarantor, and the government of the issuer's business domicile, etc. by their own conditions and/ or position of support/ assistance for the issuer.
- E) Order of Seniority in Debt Payment

The likelihood of debt payment can be different between given debts of the same issuer. The likelihood of debt payment for an individual debt is dependent on the issuer's discretion, and/ or its rank relative to other debts of the same issuer in the order of seniority in principal/ interest payment which is determined by design as financial product or by laws, etc.

A) Business Bases

The credit rating is subject to alteration if there is improvement or deterioration of the issuer's business bases, since its revenue, etc. may improve or deteriorate by the change in its business management policies, clients' preferences, competitive situation, or a technological innovation. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change in the business bases is large.

B) Financial Grounds and Asset Quality

The credit rating is subject to alteration if the issuer increases/ decreases its debt/ capital or vice versa and thereby makes its individual debt payment liability less or more bearable and its loss absorption capacity into the future decreased or increased. Also, the changes in the quality of asset under the issuer's holding may affect the credit rating, since such changes could raise or lower the likelihood of future loss of the issuer's financial grounds. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change in the financial grounds and/ or asset quality is large.

C) Liquidity Positions

The credit rating is subject to alteration if there is a change in the issuer's financial management policy or in the relations with fund procurement sources and the change thereby makes its liquidity positions improve or deteriorate. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is large.



D) Related Parties' Status and Stance of Support/ Assistance for the Issuer

The credit rating is subject to alteration if there is a change in the issuer's parent company or subsidiary, guarantor or other provider of credit enhancement, or the government of the issuer's business domicile, or other related parties' own conditions and/ or position of support/ assistance for the issuer, and the change thereby makes its business bases, financial grounds and/ or liquidity positions improve or deteriorate, and/ or making the effectiveness of guarantee and other credit enhancement improve or deteriorate. The resultant alteration of the credit rating is usually a notch, with possibility of a few notches if and when the change is large.

E) Order of Seniority in Debt Payment and Non-Payment Forgiven by Contract

The credit rating is subject to alteration if there is a change in the rated debt's status in the order of seniority relative to other debts caused by the improvement/ deterioration of the issuer's financial condition. The resultant alteration of the credit rating is usually a notch, with possibility of a few notches if and when the change is large. Also, in case of the financial products for which non-payment of interest/ principal is contractually permissible, the credit rating is subject to alteration if and when the likelihood of such non-payment is projected to increase or decrease. The resultant alteration of the credit rating could be by a notch but often as much as a few notches.

F) Rise and Fall in General Economy and Markets

The credit rating is subject to alteration if there is a rise/ fall in the general economy and/ or the markets inducing the issuer's revenues/ expenses to increase/ decrease and vice versa, etc. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is exceptionally large.

G) Various Events

The credit rating is subject to alteration on occurrence of various events, such as change in the issuer's major shareholders, M&A and other organizational change, accident, violation of the law, litigation, legal/ regulatory change, natural disaster, etc., which are unforeseeable at the time when the credit rating is determined, causing a significant change on the issuer's business bases, financial grounds, etc. The resultant alteration of the credit rating could be by a notch but more often than not as much as a few notches.

C) Liquidity Risks
