Japan Credit Rating Agency, Ltd. (JCR) announces the following credit rating.

TAKARA HOLDINGS INC. (security code: 2531)

Rationale

- (1) TAKARA HOLDINGS INC. (the "Company") is the holding company of the TAKARA Group. In addition to the alcoholic beverages and seasonings business (Takara Shuzo Co., Ltd., "Takara Shuzo"), it also operates the overseas alcoholic beverages business and Japanese food wholesales in overseas markets (TAKARA SHUZO INTERNATIONAL CO., LTD., "TAKARA INTERNATIONAL"), the bio business (TAKARA BIO INC., "TAKARA BIO") and other businesses. TAKARA INTERNATIONAL has been striving to expand the network through M&As and other means in recent years. In addition to having a strong presence in Japan and Asia for research agents, TAKARA BIO is strengthening the contract business (CDMO business) for products related to regenerative medicine and genetic analysis/testing. Although TAKARA BIO has a certain degree of independence as a listed company, the unity of the Group is strong. Therefore, JCR reflects the entire Group's creditworthiness in the ratings for the Company.
- (2) The Company's business performance is expected to remain solid for the foreseeable future on the back of the diversified business portfolio. Takara Shuzo maintains the earnings capacity through prevalence of price revisions. TAKARA INTERNATIONAL's business scale is expected to continue expanding, backed by expansion of the Japanese food market worldwide. On the other hand, TAKARA BIO, which greatly boosted the group's performance in recent years, is now facing a major negative factor of deterioration in the business environment of the life sciences market worldwide, and it is necessary to observe the speed of the performance recovery. Based on the above, JCR has affirmed the rating on the Company with Stable outlook.
- (3) For the fiscal year ending March 2024 (FY2023), the Company forecasts an operating income of 21.7 billion yen, down 42.8% over the year. Factors affecting the income decrease will be a substantial decrease in profits of TAKARA BIO stemming from a sales reduction in COVID-19 testing-related reagents and restraining from purchasing research materials worldwide. Having said that, profits will grow in Takara Shuzo because of price revision effects and curbing cost increases, and TAKARA INTERNATIONAL will likely support the overall performance securing profit growth for three fiscal years in row and an operating income greater than 10 billion yen for two fiscal years in a row. Stable profit growth is expected for TAKARA INTERNATIONAL for the foreseeable future, and product demand will likely recover for TAKARA BIO when the life science market normalizes.
- (4) The equity ratio as at the end of the second quarter of FY2023 was 52.2%. The Company has ample liquidity on hand, and the entire group is in a net cash position. Going forward, investments for expanding business base are expected to continue such as expanding business bases of the Japanese food wholesale business in overseas markets, construction of the third building of the center for gene and cell processing in the bio business. Given the group's cash flow generation capacity and own funds, it can continue to maintain the favorable financial structure, in JCR's view.

The likelihood of a given debt payment is highly conditional to its issuer's business bases - how they can be maintained/ expanded into the future and thereby secure earnings and cash flows in adequacy and in a sustainable way.

B) Financial Grounds and Asset Quality

The likelihood of debt payment is highly dependent on the degree of the issuer's indebtedness and loss absorption capacity in terms of equity capital. Also notable is that a financial institution might see a significant loss of financial grounds as a result of changes in value of the assets under its possession.

C) Liquidity Positions

The likelihood of debt payment is highly dependent on the adequacy of the issuer's cash and other sources of repayment (liquidity positions).

D) Related Parties' Status and Stance of Support/ Assistance for the Issuer

The likelihood of debt payment is affected one way or the other by the issuer's related parties such as parent company, subsidiary, guarantor, and the government of the issuer's business domicile, etc. - by their own conditions and/ or position of support/ assistance for the issuer.

A) Business Bases

The credit rating is subject to alteration if there is improvement or deterioration of the issuer's business bases, since its revenue, etc. may improve or deteriorate by the change in its business management policies, clients' preferences, competitive situation, or a technological innovation. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change in the business bases is large.

B) Financial Grounds and Asset Quality

The credit rating is subject to alteration if the issuer increases/ decreases its debt/ capital or vice versa and thereby makes its individual debt payment liability less or more bearable and its loss absorption capacity into the future decreased or increased. Also, the changes in the quality of asset under the issuer's holding may affect the credit rating, since such changes could raise or lower the likelihood of future loss of the issuer's financial grounds. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change in the financial grounds and/ or asset quality is large.

C) Liquidity Positions

The credit rating is subject to alteration if there is a change in the issuer's financial management policy or in the relations with fund procurement sources and the change thereby makes its liquidity positions improve or deteriorate. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is large.

D) Related Parties' Status and Stance of Support/Assistance for the Issuer
