Japan Credit Rating Agency, Ltd. (JCR) announces the following credit rating.

NIPPON SANSO HOLDINGS CORPORATION (security code: 4091)

Rationale

- (1) NIPPON SANSO HOLDINGS CORPORATION (the "Company") is the holding company of Japan's largest and the world's fourth largest industrial gas manufacturer group. Under the business structure of four global regions of Japan, the U.S., Europe and Asia/Oceania, it has solid business bases by supplying industrial, electronic and medical gases, along with other services, in over 30 countries. Given strong management unity in the Nippon Sanso Holdings Group (the "Group"), centering on the holding company, the Company's ratings reflect the Group's overall creditworthiness. On a separate note, while being a consolidated subsidiary of Mitsubishi Chemical Group Corporation (50.59% stake), the Company still maintains a certain degree of independence as a listed company, and thus its own creditworthiness is regarded as an important factor for the sake of rating.
- (2) The Company maintains a high earnings structure in the industrial gas business in all regions. Margins continue to improve thanks to strict price management, regional productivity improvement programs and so forth. The foundation of the overseas business is expected to become even stronger, as suggested by the Company's announcement in December 2024 to acquire Coregas Group engaging in the industrial gas business in Oceania; the deal is scheduled to close in mid-2025. Although the outlook for the global economy is difficult to predict due to U.S. tariff measures and other factors, JCR views that the Company can maintain stable earnings capacity as demand for industrial gases, which have a strong infrastructure aspect, will probably remain robust. Financial structure is improving even while growth investments are made. Based on the above, JCR affirmed the ratings on the Company and retained the Stable outlook.
- (3) As per the announcement on March 25, 2025, the Company expects core operating income to mark a new high for the fourth consecutive year in the fiscal year ended March 2025 (FY2024), rising 12.1% over the year to 186 billion yen. Even though the sales volume of mainstay separate gases has been almost leveling off, factors like price pass-through to rising costs and the weak yen will have a positive impact on profits. However, due to the recognition of impairment losses following the cancellation of plans to build a hydrogen production facility in the U.S., operating income and other incomes in lower lines are expected to be lower than the previous year. Yet, other hydrogen-related projects in India and other countries appear to be making good progress. JCR assumes that the consolidation of Coregas Group, launch of new on-site environmental plants including hydrogen plants, etc., on top of full-scale recovery in demand for gases for electronics, will positively affect FY2025 results.
- (4) Net DER (after consideration of equity content of hybrid financing) as of December 31, 2024 was 0.76x, as opposed to 0.83x a year before. In November 2024, the Company repaid 75 billion yen of subordinated loans and replaced them with senior loans, but the direction of financial improvement remains unchanged. Meanwhile, financial indicators are expected to somewhat weaken in FY2025 as two overseas M&A deals are scheduled for, including the Coregas Group acquisition. Even so, given high and stable cash flow generation capacity, JCR finds no particular concerns in the financial aspect.

The likelihood of a given debt payment is highly conditional to its issuer's business bases - how they can be maintained/ expanded into the future and thereby secure earnings and cash flows in adequacy and in a sustainable way.

- B) Financial Grounds and Asset Quality
 - The likelihood of debt payment is highly dependent on the degree of the issuer's indebtedness and loss absorption capacity in terms of equity capital. Also notable is that a financial institution might see a significant loss of financial grounds as a result of changes in value of the assets under its possession.
- C) Liquidity Positions
 - The likelihood of debt payment is highly dependent on the adequacy of the issuer's cash and other sources of repayment (liquidity positions).



- D) Related Parties' Status and Stance of Support/ Assistance for the Issuer

 The likelihood of debt payment is affected one way or the other by the issuer's related parties such as parent company, subsidiary, guarantor, and the government of the issuer's business domicile, etc. by their own conditions and/ or position of support/ assistance for the issuer.
- E) Order of Seniority in Debt Payment

 The likelihood of debt payment can be different between given debts of the same issuer. The likelihood of debt payment for an individual debt is dependent on the issuer's discretion, and/ or its rank relative to other debts of the same issuer in the order of seniority in principal/ interest payment which is determined by design as financial product or by laws, etc.

Explanation or Measure of the Potential Volatility of the Credit Rating as Required by Paragraph (a)(1)(ii)(K) of Rule 17g-7

A) Business Bases

The credit rating is subject to alteration if there is improvement or deterioration of the issuer's business bases, since its revenue, etc. may improve or deteriorate by the change in its business management policies, clients' preferences, competitive situation, or a technological innovation. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change in the business bases is large.

B) Financial Grounds and Asset Quality

The credit rating is subject to alteration if the issuer increases/ decreases its debt/ capital or vice versa and thereby makes its individual debt payment liability less or more bearable and its loss absorption capacity into the future decreased or increased. Also, the changes in the quality of asset under the issuer's holding may affect the credit rating, since such changes could raise or lower the likelihood of future loss of the issuer's financial grounds. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change in the financial grounds and/ or asset quality is large.

C) Liquidity Positions

The credit rating is subject to alteration if there is a change in the issuer's financial management policy or in the relations with fund procurement sources and the change thereby makes its liquidity positions improve or deteriorate. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is large.



D) Related Parties' Status and Stance of Support/ Assistance for the Issuer

The credit rating is subject to alteration if there is a change in the issuer's parent company or subsidiary, guarantor or other provider of credit enhancement, or the government of the issuer's business domicile, or other related parties' own conditions and/ or position of support/ assistance for the issuer, and the change thereby makes its business bases, financial grounds and/ or liquidity positions improve or deteriorate, and/ or making the effectiveness of guarantee and other credit enhancement improve or deteriorate. The resultant alteration of the credit rating is usually a notch, with possibility of a few notches if and when the change is large.

E) Order of Seniority in Debt Payment and Non-Payment Forgiven by Contract

The credit rating is subject to alteration if there is a change in the rated debt's status in the order of seniority relative to other debts caused by the improvement/ deterioration of the issuer's financial condition. The resultant alteration of the credit rating is usually a notch, with possibility of a few notches if and when the change is large. Also, in case of the financial products for which non-payment of interest/ principal is contractually permissible, the credit rating is subject to alteration if and when the likelihood of such non-payment is projected to increase or decrease. The resultant alteration of the credit rating could be by a notch but often as much as a few notches.

F) Rise and Fall in General Economy and Markets

The credit rating is subject to alteration if there is a rise/ fall in the general economy and/ or the markets inducing the issuer's revenues/ expenses to increase/ decrease and vice versa, etc. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is exceptionally large.

A) Business Bases

The credit rating herewith presented could be changed if and when the assumptions made at the time of its determination turn out to be inaccurate with regard to the issuer's business bases and powers of earning or cash flow generation, etc. The resultant change of the credit rating is most likely by a notch, as JCR speculates, but possibly as much as a few notches if the development is rapid in improvement or deterioration of the issuer's business bases on some drastic change in the operational environments, etc.

B) Financial Grounds and Asset Quality

The credit rating herewith presented could be changed if and when the assumptions made at the time of its determination turn out to be inaccurate with regard to the issuer's financial grounds and asset quality. The resultant change of the credit rating is most likely by a notch, as JCR speculates, but



possibly as much as a few notches if the development is rapid in improvement or deterioration of the issuer's financial grounds and/ or asset quality on some drastic change in its business bases.

C) Liquidity Risks

The credit rating herewith presented could be changed if and when the assumptions made at the time of its determination turn out to be inaccurate with regard to the issuer's liquidity positions. The resultant change of the credit rating is most likely by a notch, as JCR speculates, but possibly as much as a few notches if the development is rapid in improvement or deterioration of the issuer's liquidity positions on some drastic change in its financial management policy or relations with fund procurement sources, etc.

- D) Order of Seniority in Debt Payment and Non-Payment Forgiven by Contract
 - The credit rating herewith presented could be changed if and when the assumptions made at the time of its determination turn out to be inaccurate with regard to the order of seniority in repayment of interests and principal. JCR assumes the resultant change of the credit rating is most likely by a notch. The change could be as much as a few notches if the issuer's financial structure differs so much and thereby the balance between debts shifted so greatly. Rating change is also possible in case of the financial products for which non-payment of interest/ principal is contractually permissible, if and when the assumptions made at the time of its determination turns out to be inaccurate. The change of the credit rating is assumed to be by a notch but often as much as a few notches.
- E) Rise and Fall in General Economy and Markets

The credit rating herewith presented could be changed if and when the assumptions made at the time of its determination turn out to be inaccurate with regard to the prospects of general economy and markets.
