Japan Credit Rating Agency, Ltd. (JCR) announces the following credit rating.

Advance Residence Investment Corporation (security code: 3269)

Rationale

- (1) Advance Residence Investment Corporation ("ADR") is a residential J-REIT sponsored by the ITOCHU Group. Its asset manager ("AM") is ITOCHU REIT Management Co., Ltd. As of the end of July 2022, ADR's portfolio consists of 277 properties with 21,853 leasable units, and its total acquisition price is 468.7 billion yen, the largest among residential J-REITs. By area, properties in Tokyo 23 Wards account for 71% (based on an acquisition price); and by type, single and compact types in total account for 64% (based on a leasable area).
- (2) ADR's leasing business operations have been robust. The occupation rate of the entire portfolio tentatively dropped to 95.2% due to the COVID-19 pandemic, but recovered to 96.7% in January 2023, party thanks to relaxation of application conditions, such as suppressing increases in rents. In addition to a highly diversified portfolio in terms of properties and tenants maintained, JCR can confirm track records including the NOI yield on an acquisition price basis staying in the mid-5% range (5.7% for the period ended July 2022). JCR hence sees that ADR will be able to continue to ensure stable portfolio cash flow. Moreover, JCR believes that ADR's sound financial management is continuing, given its stable total assets-based LTV, among others. Based on the above, JCR has affirmed the ratings on ADR with Stable outlook.
- (3) With respect to external growth, ADR has been continuing its efforts to maintain the goals at the time of property acquisition. After the period ended July 2022, ADR sold RESIDIA Kami-Ikebukuro and Tokyo Student-House Wako, while it acquired RESIDIA Kotoen, RESIDIA Tamatsukuri and RESIDIA Kumamoto Karashima. ADR thereby is working to strengthen the stability of its cash flow with external growth of its portfolio. JCR will observe whether the external growth will keep progressing in line with the goals at the time of acquisition (such as securing an NOI yield of around 4% after depreciation), through selective investments centered on the sponsor pipelines. In terms of internal growth, the AM's engineering department, etc. have carried out large repair works and value enhancement works to maintain and strengthen the competitiveness of properties. JCR will follow up on the ongoing efforts aimed at further strengthening of portfolio cash flow, including large repair works for responding to aging and value enhancement works for competitiveness improvement.
- (4) The total asset-based LTV and appraisal LTV, stand respectively at 49.0% and 33.9% at end-July 2022, controlled within the AM's scope of assumption. The portfolio's unrealized gain, a financial buffer, amounts to 235.2 billion yen (unrealized gain ratio: 53.7%) as of the same date. There are no particular concerns over stability in financing, as shown by the maintained lender formation mainly consisting of megabanks, lengthened average remaining years of debts, staggered maturities, access to direct financing through issuance of investment corporation bonds including green bonds, and establishment of a commitment line of 20 billion yen. In addition, ADR secures a certain level of flexibility in asset management, including the dividend policy, through reserves for temporary difference adjustments (balance after dividend payments for the fiscal period ended July 2022: 29.5 billion yen), which were transferred from gains on negative goodwill generated upon its merger.

 - The credit rating methodology assumes, in principle, that the factors posted in the below are particularly important for such likelihood to be determined, and that the rating determination is made by evaluating each of them not only quantitatively but also employing qualitative analyses.
 - A) Portfolios

The likelihood of a given debt payment is highly conditional to its issuer's portfolios - how they can be maintained/ enhanced into the future and thereby secure earnings and cash flows in adequacy and in a sustainable way.

B) Financial Grounds and Asset Quality

The likelihood of debt payment is highly dependent on the degree of the issuer's indebtedness and loss absorption capacity in terms of equity capital. Also notable is that a J-REIT might see a significant loss of financial grounds as a result of changes in value of the assets under its possession.

C) Liquidity Positions

The likelihood of debt payment is highly dependent on the adequacy of the issuer's cash and other sources of repayment (liquidity positions) including certainty of refinancing.

D) Related Parties' Status and Stance of Support/ Assistance for the Issuer

The likelihood of debt payment is affected one way or the other by the issuer's related parties such as sponsor, asset manager, guarantor, and the government of the issuer's business domicile, etc. - by their own conditions and/ or position of support/ assistance for the issuer.

The likelihood of debt payment can be different between given debts of the same issuer. A) Portfolios


The credit rating is subject to alteration if there is improvement or deterioration of quality, competitive strength and diversification in the issuer's portfolios, since its revenue, etc. may improve or deteriorate by the change in its investment strategies, tenants' preferences, competitive situation, or a technological innovation. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change in the portfolios is large.

B) Financial Grounds and Asset Quality

The credit rating is subject to alteration if the issuer increases/ decreases its debt/ capital or vice versa and thereby makes its individual debt payment liability less or more bearable and its loss absorption capacity into the future decreased or increased. Also, the changes in the quality of asset under the issuer's holding may affect the credit rating, since such changes could raise or lower the likelihood of future loss of the issuer's financial grounds. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change in the financial grounds and/ or asset quality is large.

C) Liquidity Positions

The credit rating is subject to alteration if there is a change in the issuer's financial management policy or in the relations with fund procurement sources and the change thereby makes its liquidity positions improve or deteriorate. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is large.



The credit rating is subject to alteration if there is a change in the issuer's sponsor or asset manager, guarantor or other provider of credit enhancement, or the government of the issuer's business domicile, or other related parties' own conditions and/ or position of support/ assistance for the issuer, and the change thereby makes its portfolios, financial grounds and/ or liquidity positions improve or deteriorate, and/ or making the effectiveness of guarantee and other credit enhancement improve or deteriorate. E) Order of Seniority in Debt Payment and Non-Payment Forgiven by Contract

The resultant alteration of the credit rating could be by a notch but often as much as a few notches.

F) Rise and Fall in General Economy and Markets

The credit rating herewith presented could be changed if and when the assumptions made at the time of its determination turn out to be inaccurate with regard to the issuer's portfolios and powers of earning or cash flow generation, etc. The resultant change of the credit rating is most likely by a notch, as JCR speculates, but possibly as much as a few notches if the development is rapid in improvement or deterioration of quality, competitive strength and diversification in the issuer's portfolios on some drastic change in the market environments, etc.



B) Financial Grounds and Asset Quality

The credit rating herewith presented could be changed if and when the assumptions made at the time of its determination turn out to be inaccurate with regard to the issuer's financial grounds and asset quality. The resultant change of the credit rating is most likely by a notch, as JCR speculates, but possibly as much as a few notches if the development is rapid in improvement or deterioration of the issuer's financial grounds and/ or asset quality on some drastic change in its portfolios.

C) Liquidity Risks

The credit rating herewith presented could be changed if and when the assumptions made at the time of its determination turn out to be inaccurate with regard to the issuer's liquidity positions including certainty of refinancing. The resultant change of the credit rating is most likely by a notch, as JCR speculates, but possibly as much as a few notches if the development is rapid in improvement or deterioration of the issuer's liquidity positions on some drastic change in its financial management policy or relations with fund procurement sources, etc.

D) Related Parties' Status and Stance of Support/ Assistance for the Issuer

The credit rating herewith presented could be changed if and when the assumptions made at the time of its determination turn out to be inaccurate with regard to the issuer's sponsor or asset manager, guarantor or other providers of credit enhancement, the government of the issuer's business domicile or other related parties' status and stance of support/ assistance for the issuer. The resultant change of the credit rating is most likely by a notch, as JCR speculates, but possibly as much as a few notches if there is a major change on the part of related parties, such as replacement, disappearance, some drastic improvement/ deterioration of financial grounds/ balances, etc.

E) Rise and Fall in General Economy and Markets

The credit rating herewith presented could be changed if and when the assumptions made at the time of its determination turn out to be inaccurate with regard to the prospects of general economy and markets of e.g. real estate or interest rates. 
