Japan Credit Rating Agency, Ltd. (JCR) announces the following credit ratings.

The Republic of Poland

Rationale

- (1) Poland is the largest economy in Central and Eastern Europe (CEE) with a nominal GDP of approximately USD 860 billion and a population of around 38 million in 2024. The ratings primarily reflect the country's relatively developed economic base and solid external liquidity. In 2024, private consumption recovered due to an increase in nominal wages, and the economy grew much faster than in 2023. In 2025, a high economic growth rate of over 3% is expected, supported by strong private consumption and increased capital investment. While the fiscal deficit is on an upward trend due to increased defense expenditures, JCR holds that certain increase of the fiscal burdens can be tolerated. Based on the above, JCR has affirmed the ratings with Stable outlook.
- (2) The Polish economy is relatively developed with its per capita GDP estimated at around USD 44,000 (in ppp terms) in 2023. It grew 2.9% in real GDP terms in 2024, compared to 0.1% in 2023, as private consumption recovered on rising nominal wages amid a solid labor market and a slowdown of the inflation rate. CPI settled below 3% in the first half of 2024, but began to pick up again in the second half of the year, currently hovering around 5%. Factors behind this include rising energy prices and soaring service prices, however monetary policy remains tight and inflation is expected to improve gradually towards 2026. Under the Tusk administration, the freeze on RRF disubursments was lifted in February 2024 to pave the way for resumption of fund disbursement, which also helped to boost the economic growth. JCR expects that the inflow of EU funds will make a significant contribution to capital investment and that a strong labor market will support private consumption, leading to a real GDP growth rate higher than 3% in 2025.
- (3) The general government fiscal deficit (ESA 2010) is on the rise. Although revenues increased in 2024 due to the economic recovery, the fiscal deficit is also estimated to have expanded to around 6% of GDP due to higher defense expenditures and increased public expenditures necessitated by wage hikes for public servants and teachers and expansion of child allowances. While tax revenues are expected to expand in 2025 due to increased personal income tax revenues as a result of wage hikes and an increase in the value-added tax rate for tobacco products, expenditures, particularly defense spending, may also expand, and the government predicts a fiscal deficit equivalent to 5.5% of GDP for the year. The fiscal deficit is seen to remain at around 5% of GDP after 2026 due to high defense expenditures, but the government has announced a policy to cut the deficit to less than 3% of GDP from 2028 by curbing public expenditures, and JCR believes that Poland will be able to attain the excessive deficit procedure targets imposed by European Commission. While the government debt may increase to around 60% of GDP, it is expected to remain at the average level of A-range countries rated by JCR.
- (4) The country's current account surplus narrowed in 2024 from the previous year to 0.1% of GDP. While the economies of its trading partners were stagnant, Poland's domestic demand was strong, and the trade balance turned to a deficit as imports grew faster than exports. Capital inflows through direct investment remain strong, helping to retain the country's solid external liquidity. Moreover, its net external debt in IIP terms is on the downtrend. The Polish financial system stays stable. The banking sector is posting stable profits, its nonperforming loan ratio is on a downward trend, and its capital adequacy ratio is at a sufficient level. Although losses on Swiss franc-denominated housing loans may increase in the future, banks have already increased their provisions and have the capacity to absorb additional costs to a certain extent with their solid profits. Therefore, JCR sees little possibility of a situation where the stability of the financial system can be seriously impaired.

The likelihood of a given debt payment is highly correlated to fiscal balance, public debt and other factors of the issuing government's fiscal condition.

C) External Positions

The likelihood of a given debt payment is highly correlated to the liquidity positions which change along with the international balance of payments and the international investment position.



D) Social and Political Bases and Economic Policy

The likelihood of a given debt payment is highly conditional to the social and political stability, effectiveness of economic and monetary policies as well as international economics.

E) Related Parties' Stance of Support/ Assistance for the Government

The likelihood of a given debt payment is affected by the stance of the credit enhancement provider and other related parties with regard to their stance of support/ assistance for the issuing government.

F) Order of Seniority in Debt Payment

The likelihood of debt payment can be different between given debts of the same issuer. The likelihood of debt payment for an individual debt is dependent on the issuing government's will, and/ or its rank relative to other debts of the same government in the order of seniority in principal/ interest payment which is determined by design as financial product or by international practice, etc.

E) Related Parties' Stance of Support/ Assistance for the Issuer
