Japan Credit Rating Agency, Ltd. (JCR) announces the following credit rating.

Mitsubishi Chemical Group Corporation (security code: 4188)

<Affirmation>

Long-term Issuer Rating: A+

Rationale

- (1) Mitsubishi Chemical Group Corporation (the "Company") is the holding company of Japan's largest diversified chemical group (the "Mitsubishi Chemical Group"). The Mitsubishi Chemical Group operates five segments: Specialty Materials, Industrial Gases, Health Care, MMA and Basic Materials. It offers a large number of highly competitive products, including various types of high-performance materials, as well as MMA with the world's top share. The NIPPON SANSO HOLDINGS Group in the Industrial Gasses segment ranks fourth in the global market, while Mitsubishi Tanabe Pharma Corporation ("Mitsubishi Tanabe Pharma") in Health Care enjoys its position as a leading supplier of ethical pharmaceuticals in Japan. The Company in recent years has been working to maximize corporate value through selection and concentration based on market growth potential, responses to carbon neutrality, etc., further improvement of efficiency for the entire group and so forth. The ratings reflect the creditworthiness of the Mitsubishi Chemical Group as a whole.
- (2) The Company's performance will probably remain solid. The current business environment is severe due to such factors as the inflation, adjustments in the semiconductor market and deterioration in supply-demand balance for petrochemicals because of facility enhancement in China. That said, Specialty Materials has a certain level of earnings capacity on the back of successful business diversification, etc., and Industrial Gases is achieving profit growth thanks to strict price management. Also, business momentum has been favorable for Health Care. Basic Materials may remain sluggish for a while and needs to be restructured, but its performance is unlikely to weaken from the current level. Moreover, company-wide cost reduction efforts that have been underway to date are steadily producing positive results. On the financial front, even though the Company still faces some challenges, it is steadily improving its finances and will probably be able to remain in that direction for the time being. Based on the above, JCR affirmed the ratings on the Company and retained the Stable outlook. On a separate note, the Company will transition to a new management structure in April 2024, but JCR assumes that there will be no major changes in its initiatives such as the portfolio reform.
- (3) The Company forecasts core operating income for the fiscal year ending March 2024 at 250 billion yen, falling 23.2% from the previous year due to a drop in demand for core products in Specialty Materials, decline in market prices and sales of carbon products in Basic Materials and the elimination of royalties recorded in lump sum in the previous year in Health Care. That said, the sale of Radicava, an oral agent for treating ALS, is expanding in North America for Health Care, and steady performance is projected for pharmaceuticals in and outside Japan. Moreover, Industrial Gases is expected to achieve double-digit year-on-year profit growth, albeit weak demand, with the revision of selling prices and productivity improvement in each region, the yen's depreciation, etc. and support the Group's overall performance.
- (4) Interest-bearing debt remains high at over 2 trillion yen. Yet, net D/E ratio as of December 31, 2023 was 1.2x, improving from 1.8x at March 31, 2020 when it rose due to the consolidation of Mitsubishi Tanabe Pharma. Although working capital tends to run up due to the high prices of raw materials and fuels, the increase in interest-bearing debt has been curbed with reduction in inventory, business divestiture, etc.; efforts are also being made to expand capital with steady profit accumulation. The Company will likely keep making a considerable amount of capital expenditures into the future, mainly in Specialty Materials, but JCR assumes that the Company will be able to improve the financial structure further while managing such spending.

The likelihood of a given debt payment is highly conditional to its issuer's business bases - how they can be maintained/ expanded into the future and thereby secure earnings and cash flows in adequacy and in a sustainable way.

B) Financial Grounds and Asset Quality

The likelihood of debt payment is highly dependent on the degree of the issuer's indebtedness and loss absorption capacity in terms of equity capital. Also notable is that a financial institution might see a significant loss of financial grounds as a result of changes in value of the assets under its possession.

C) Liquidity Positions

The likelihood of debt payment is highly dependent on the adequacy of the issuer's cash and other sources of repayment (liquidity positions).



D) Related Parties' Status and Stance of Support/ Assistance for the Issuer

The likelihood of debt payment is affected one way or the other by the issuer's related parties such as parent company, subsidiary, guarantor, and the government of the issuer's business domicile, etc. - by their own conditions and/ or position of support/ assistance for the issuer.

E) Order of Seniority in Debt Payment

The likelihood of debt payment can be different between given debts of the same issuer. The likelihood of debt payment for an individual debt is dependent on the issuer's discretion, and/ or its rank relative to other debts of the same issuer in the order of seniority in principal/ interest payment which is determined by design as financial product or by laws, etc.

A) Business Bases

The credit rating is subject to alteration if there is improvement or deterioration of the issuer's business bases, since its revenue, etc. may improve or deteriorate by the change in its business management policies, clients' preferences, competitive situation, or a technological innovation. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change in the business bases is large.

B) Financial Grounds and Asset Quality

The credit rating is subject to alteration if the issuer increases/ decreases its debt/ capital or vice versa and thereby makes its individual debt payment liability less or more bearable and its loss absorption capacity into the future decreased or increased. Also, the changes in the quality of asset under the issuer's holding may affect the credit rating, since such changes could raise or lower the likelihood of future loss of the issuer's financial grounds. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change in the financial grounds and/ or asset quality is large.

C) Liquidity Positions

The credit rating is subject to alteration if there is a change in the issuer's financial management policy or in the relations with fund procurement sources and the change thereby makes its liquidity positions improve or deteriorate. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is large.



D) Related Parties' Status and Stance of Support/ Assistance for the Issuer

The credit rating is subject to alteration if there is a change in the issuer's parent company or subsidiary, guarantor or other provider of credit enhancement, or the government of the issuer's business domicile, or other related parties' own conditions and/ or position of support/ assistance for the issuer, and the change thereby makes its business bases, financial grounds and/ or liquidity positions improve or deteriorate, and/ or making the effectiveness of guarantee and other credit enhancement improve or deteriorate. The resultant alteration of the credit rating is usually a notch, with possibility of a few notches if and when the change is large.

E) Order of Seniority in Debt Payment and Non-Payment Forgiven by Contract

The credit rating is subject to alteration if there is a change in the rated debt's status in the order of seniority relative to other debts caused by the improvement/ deterioration of the issuer's financial condition. The resultant alteration of the credit rating is usually a notch, with possibility of a few notches if and when the change is large. Also, in case of the financial products for which non-payment of interest/ principal is contractually permissible, the credit rating is subject to alteration if and when the likelihood of such non-payment is projected to increase or decrease. The resultant alteration of the credit rating could be by a notch but often as much as a few notches.

F) Rise and Fall in General Economy and Markets

The credit rating is subject to alteration if there is a rise/ fall in the general economy and/ or the markets inducing the issuer's revenues/ expenses to increase/ decrease and vice versa, etc. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is exceptionally large.

G) Various Events

The credit rating is subject to alteration on occurrence of various events, such as change in the issuer's major shareholders, M&A and other organizational change, accident, violation of the law, litigation, legal/ regulatory change, natural disaster, etc., which are unforeseeable at the time when the credit rating is determined, causing a significant change on the issuer's business bases, financial grounds, etc. The resultant alteration of the credit rating could be by a notch but more often than not as much as a few notches.
