Japan Credit Rating Agency, Ltd. (JCR) announces the following credit rating.

MORI HILLS REIT INVESTMENT CORPORATION

Rationale

- (1) MORI HILLS REIT INVESTMENT CORPORATION ("MHR") is a diversified J-REIT sponsored by MORI BUILDING Co., Ltd. (the "Sponsor"). Its asset manager (the "AM") is Mori Building Investment Management Co., Ltd. The current portfolio consists of following 11 properties: 10 properties with a certain level of superiority in terms of location, scale, specification, etc. (defined as Premium Properties by MHR); and Roppongi View Tower, which does not fall under the Premium Properties. The asset size based on the total acquisition price reaches 407.7 billion yen.
- (2) A stable track record overall can be confirmed for MHR's leasing business operations based on the strong cooperative relationship with the Sponsor group. MHR shows achievements, such as external growth by using the Sponsor's property pipeline, an average NOI yield of 3.6% in the period ended January 2023, and an occupancy rate of 99.1% at the end of April 2023. Although occupancy rates and rents are somewhat weak for part of pass-through type master lease properties (office buildings), for which fixed-rent master leases by the Sponsor are not set, the impact seems to be limited. Also given the support of fixed-rent master leases by the Sponsor (percentage in the total monthly rents: about 66%), MHR is assumed to maintain stable portfolio cash flow. Moreover, in light of the state of leverage control, etc., the financial soundness has been kept. Based on the above, JCR has affirmed the ratings on MHR with Stable outlook.
- (3) While planning to dispose the beneficial interests of Laforet Harajuku (limited proprietary right of land) in June and December 2023 (7% quasi-co ownership for each time), MHR is expected to continue to acquire properties going forward by leveraging the Sponsor's property pipeline with first refusal rights for external growth. JCR is paying attention to whether MHR will be able to advance the external growth while firmly maintaining the investment criteria held at the time of acquisition. In terms of internal growth, JCR will continue to follow up on the early conclusion of lease contracts for ARK Hills South Tower (occupancy rate at end-January 2023: 84.4%), of which occupancy rate is slightly weakening, and response to aging properties by using CAPEX, etc. (the average age of the portfolio at end-January 2023: 21.2 years), among others.
- (4) MHR's total assets-based book-value LTV stood at 46.3% at end-January 2023, kept controlled in the mid-40% level based on the AM's policy. At end-January 2023, unrealized gains on the portfolio, which serve as a financial buffer, amounted to 111.9 billion yen (unrealized gains ratio: 28.5%). There is no particular concern in terms of financing, given track records shown, such as maintaining a lender formation mainly comprised of major banks, diversified financing methods through issuing investment corporation bonds (green bonds) on the back of efforts for sustainability initiatives, average remaining years of debts kept longer than 4.0 years (4.2 years at end-January 2023), and staggered due dates.

B) Financial Grounds and Asset Quality

The likelihood of debt payment is highly dependent on the degree of the issuer's indebtedness and loss absorption capacity in terms of equity capital. Also notable is that a J-REIT might see a significant loss of financial grounds as a result of changes in value of the assets under its possession.

C) Liquidity Positions

The likelihood of debt payment is highly dependent on the adequacy of the issuer's cash and other sources of repayment (liquidity positions) including certainty of refinancing.

D) Related Parties' Status and Stance of Support/ Assistance for the Issuer

The likelihood of debt payment is affected one way or the other by the issuer's related parties such as sponsor, asset manager, guarantor, and the government of the issuer's business domicile, etc. - by their own conditions and/ or position of support/ assistance for the issuer.

The credit rating is subject to alteration if there is improvement or deterioration of quality, competitive strength and diversification in the issuer's portfolios, since its revenue, etc. may improve or deteriorate by the change in its investment strategies, tenants' preferences, competitive situation, or a technological innovation. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change in the portfolios is large.

B) Financial Grounds and Asset Quality

The credit rating is subject to alteration if the issuer increases/ decreases its debt/ capital or vice versa and thereby makes its individual debt payment liability less or more bearable and its loss absorption capacity into the future decreased or increased. Also, the changes in the quality of asset under the issuer's holding may affect the credit rating, since such changes could raise or lower the likelihood of future loss of the issuer's financial grounds. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change in the financial grounds and/ or asset quality is large.

C) Liquidity Positions

The credit rating is subject to alteration if there is a change in the issuer's financial management policy or in the relations with fund procurement sources and the change thereby makes its liquidity positions improve or deteriorate.
