### *Rationale*

- (1) TOKYU CORPORATION (the "Company") is the core company of the Tokyu Group. The Company changed its corporate name to TOKYU CORPORATION (the same name with the previous one in English) on September 2, 2019, and transferred its railway business to newly established TOKYU RAILWAYS on October 1, 2019. The railways centered on the Den-en-toshi Line and the Toyoko Line are popular as commuting lines and their mutual operations with other railway companies' lines are well developed. Furthermore, the Company operates many real estate facilities for leasing, commercial facilities, hotels, etc. mainly in the areas along its railway lines. In spring 2023, Tokyu Kabukicho Tower is scheduled to start operation.
- (2) Although demand in its transportation business and hotel and resort business has yet to fully recover from the damage of COVID-19 pandemic, it has already bottomed out. In addition, the real estate business, which underpins earnings, remains robust. However, the extent and speed of future demand recovery is very uncertain. It would be important to boost profits by realizing the effects of company-wide business structure reforms in railway, bus, hotel, and other operations. The pandemic has not had a significant negative impact on the financial base. Based on the above, JCR has affirmed the ratings on the Company with Stable outlook.
- (3) The Company expects an operating profit of 25 billion yen for the fiscal year ending March 2022 (FY2021) (an operating loss of 31.6 billion yen for the previous period). Compared to the previous fiscal year, which was strongly affected by the pandemic, railway transportation and hotel operations are planned to improve, and sales of large properties in the real estate business are expected to be a factor behind the profit improvement. The speed of recovery in demand going forward is uncertain, and there are concerns about a structural decline in demand due to telework, etc. In response to such issues, the Company is promoting business structural reforms, such as expansion of driver-only service in the railway business, optimization of maintenance work by utilizing data, diversification of guest rooms in the hotel business, and restructuring of the store network. On January 7, the Company applied to the Ministry of Land, Infrastructure, Transport and Tourism for a railroad fare revision with an average revision rate of 12.9%. JCR will confirm its progress going forward.
- (4) As of the end of FY2020, the equity ratio was 28.4% (29.8% a year earlier) and the net DER was 1.6x (1.5x). Although shareholders' equity declined due to recording of a net loss and other factors, an increase in net interest-bearing debt was restrained to a certain extent by efforts to reduce investment, etc., and the extent of the deterioration was limited. It is unlikely that the shareholders' equity will further decline in the future. The Company intends to positively work on construction of Tokyu Kabukicho Tower as a central-Tokyo development project, and development of areas along its railways, but from the viewpoint of the prospect of the cash flow and so forth, the present financial standing will likely be maintained for the time being.

**A) Business Bases**

The likelihood of a given debt payment is highly conditional to its issuer's business bases - how they can be maintained/ expanded into the future and thereby secure earnings and cash flows in adequacy and in a sustainable way.

**B) Financial Grounds and Asset Quality**

The likelihood of debt payment is highly dependent on the degree of the issuer's indebtedness and loss absorption capacity in terms of equity capital. Also notable is that a financial institution might see a significant loss of financial grounds as a result of changes in value of the assets under its possession.

**C) Liquidity Positions**

The likelihood of debt payment is highly dependent on the adequacy of the issuer's cash and other sources of repayment (liquidity positions).

D) Related Parties' Status and Stance of Support/ Assistance for the Issuer

The likelihood of debt payment is affected one way or the other by the issuer's related parties such as parent company, subsidiary, guarantor, and the government of the issuer's business domicile, etc. - by their own conditions and/ or position of support/ assistance for the issuer.

E) Order of Seniority in Debt Payment

The likelihood of debt payment can be different between given debts of the same issuer. The likelihood of debt payment for an individual debt is dependent on the issuer's discretion, and/ or its rank relative to other debts of the same issuer in the order of seniority in principal/ interest payment which is determined by design as financial product or by laws, etc.

The credit rating is subject to alteration if there is improvement or deterioration of the issuer's business bases, since its revenue, etc. may improve or deteriorate by the change in its business management policies, clients' preferences, competitive situation, or a technological innovation. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change in the business bases is large.

### B) Financial Grounds and Asset Quality

The credit rating is subject to alteration if the issuer increases/ decreases its debt/ capital or vice versa and thereby makes its individual debt payment liability less or more bearable and its loss absorption capacity into the future decreased or increased. Also, the changes in the quality of asset under the issuer's holding may affect the credit rating, since such changes could raise or lower the likelihood of future loss of the issuer's financial grounds. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change in the financial grounds and/ or asset quality is large.

### C) Liquidity Positions

The credit rating is subject to alteration if there is a change in the issuer's financial management policy or in the relations with fund procurement sources and the change thereby makes its liquidity positions improve or deteriorate. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is large.

**D) Related Parties' Status and Stance of Support/ Assistance for the Issuer**

The credit rating is subject to alteration if there is a change in the issuer's parent company or subsidiary, guarantor or other provider of credit enhancement, or the government of the issuer's business domicile, or other related parties' own conditions and/ or position of support/ assistance for the issuer, and the change thereby makes its business bases, financial grounds and/ or liquidity positions improve or deteriorate, and/ or making the effectiveness of guarantee and other credit enhancement improve or deteriorate. The resultant alteration of the credit rating is usually a notch, with possibility of a few notches if and when the change is large.

**E) Order of Seniority in Debt Payment and Non-Payment Forgiven by Contract**

The credit rating is subject to alteration if there is a change in the rated debt's status in the order of seniority relative to other debts caused by the improvement/ deterioration of the issuer's financial condition. The resultant alteration of the credit rating is usually a notch, with possibility of a few notches if and when the change is large. Also, in case of the financial products for which non-payment of interest/ principal is contractually permissible, the credit rating is subject to alteration if and when the likelihood of such non-payment is projected to increase or decrease. The resultant alteration of the credit rating could be by a notch but often as much as a few notches.

**F) Rise and Fall in General Economy and Markets**

The credit rating is subject to alteration if there is a rise/ fall in the general economy and/ or the markets inducing the issuer's revenues/ expenses to increase/ decrease and vice versa, etc. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is exceptionally large.

**G) Various Events**

The credit rating is subject to alteration on occurrence of various events, such as change in the issuer's major shareholders, M&A and other organizational change, accident, violation of the law, litigation, legal/ regulatory change, natural disaster, etc., which are unforeseeable at the time when the credit rating is determined, causing a significant change on the issuer's business bases, financial grounds, etc. The resultant alteration of the credit rating could be by a notch but more often than not as much as a few notches.

The resultant change of the credit rating is most likely by a notch, as JCR speculates, but possibly as much as a few notches if the development is rapid in improvement or deterioration of the issuer's liquidity positions on some drastic change in its financial management policy or relations with fund procurement sources, etc.

D) Order of Seniority in Debt Payment and Non-Payment Forgiven by Contract

The credit rating herewith presented could be changed if and when the assumptions made at the time of its determination turn out to be inaccurate with regard to the order of seniority in repayment of interests and principal. JCR assumes the resultant change of the credit rating is most likely by a notch. The change could be as much as a few notches if the issuer's financial structure differs so much and thereby the balance between debts shifted so greatly. Rating change is also possible in case of the financial products for which non-payment of interest/ principal is contractually permissible, if and when the assumptions made at the time of its determination turns out to be inaccurate. The change of the credit rating is assumed to be by a notch but often as much as a few notches.

E) Rise and Fall in General Economy and Markets

The credit rating herewith presented could be changed if and when the assumptions made at the time of its determination turn out to be inaccurate with regard to the prospects of general economy and markets. JCR expects the change should be most likely by a notch but could be as much as a few notches, should the economy or the markets change so greatly.
