#### Rationale

- (1) MS&AD Insurance Group is Japan's major non-life insurance group which has Mitsui Sumitomo Insurance Company, Limited ("MSI") and Aioi Nissay Dowa Insurance Company, Limited ("ADI") as the 2 core companies, and also Mitsui Sumitomo Aioi Life Insurance Co., Ltd. ("MS Aioi Life"), Mitsui Sumitomo Primary Life Insurance Co., Ltd. ("MS Primary Life"), and others under umbrella of its holding company, MS&AD Insurance Group Holdings, Inc. ("MS&AD Holdings"). Holding also many overseas insurance companies, it is building a diversified business portfolio in terms of risks and geographical areas. The 2 core companies' ratings are the same as the Group's overall creditworthiness, which is considered equivalent to AA+, based on the assessment of the strong business bases where the 2 core companies display their strengths in mutually different areas in the domestic non-life insurance business, stable earnings capacity backed by diversification with the domestic life insurance and international businesses, financial soundness, etc. Earnings improvement of international business including MS Amlin plc ("MS Amlin") remains an issue to be addressed. MS&AD Holdings' rating is 1 notch below that of the core companies to reflect a holding company's structurally subordinate nature in light of the fact that its double leverage ratio has been slightly high.
- (2) While MSI globally offers insurance and financial services backed by the domestic huge customer base centered on the Mitsui Group and the Sumitomo Group, ADI has strength in its partnership with the TOYOTA Group and the Nippon Life Group. The Group's adjusted profit based on internal control shows a slight delay of progress in diversification of its business portfolio due partly to delay of the international business' earnings recovery. In FY2020, impact of natural disasters in Japan calmed down compared to the previous two fiscal years, and the COVID-19 pandemic impact was generally limited, despite the increase of some overseas payments, with a positive contribution to the bottom line in Japan. While the impact of natural disasters in Japan cannot be avoided in the future, JCR believes that the Group will be able to post stable profits, given that profit of domestic non-life insurance business has been basically steady and that it has advanced its building of a well-diversified business portfolio.
- (3) In the domestic non-life insurance business, net premiums written of the 2 core companies were almost unchanged in FY2020. The combined ratio of automobile insurance, which accounts for about 50% of the total, has declined further due to a decrease in the number of accidents caused



by the voluntary restraint of going out under the COVID-19 pandemic crisis. Fire insurance, on the other hand, saw an increase in revenue mainly thanks to rate hikes, but there is room for improvement in profitability. It will take some time to secure profitability, and the key point will be whether premium rates and products can be revised appropriately based on the balance of risk and return. JCR would also like to pay attention to how much effect the cost reduction through R&D investments and business style reforms can have on the expense ratio. In the domestic life insurance business, while MS Aioi Life sells protection insurance products with relatively high profitability through various sales channels, mainly non-life insurance agents, MS Primary Life has top-class business base as a company specializing in bancassurance. Although these 2 companies develop strategies based on characteristics of products and channels, their contract performance has been stagnant under the COVID-19 pandemic crisis.

- (4) In the international business, MS Amlin's profit level has been far lower than the initially planned level with the significantly increased payments for claims for non-cat lines in addition to effects from overseas natural disasters in previous years. MSI carried out organizational restructuring for the purpose of more efficient operations of the Group's international business, with MSI's overseas and other businesses in charge of each region, and is strengthening its grip on the Group's international business. Concerning the improvement of MS Amlin's profitability, which is an issue, the Group has been withdrawing from unprofitable lines and raising premium rates continuously. Although the Group's adjusted profit for international business was in the red in FY2020 due to factors such as the increased claims payments under the COVID-19 pandemic crisis, there are signs of recovery in the combined ratio, which excludes these one-time factors. The Group expects a significant recovery in the adjusted profit for international business in FY2021, and JCR will confirm the results of its profit improvement measures and performance. ADI is promoting global development of mobility service, leveraging TOYOTA Group's customer base, for its international business, and is generating good results in differentiating itself from others in terms of products and services for telematics auto insurance where it has strength.
- (5) The Group, based on ERM cycle, aims to increase its enterprise value through realizing improvement of profitability and capital efficiency, while securing soundness. As shown by the utilization of economic value-based assessment in the product strategy, investment policy, retention and reinsurance policies, the degree of establishment of ERM has increased. Its efforts, including control of insurance underwriting risks, reduction of price fluctuation risk from the cross-shareholdings, and strategic utilization of reinsurance, are contributing to reduction of fluctuations in equity capital and earnings. In light of the fact that its earnings and financials have been affected by natural disasters both in Japan and abroad and international business, penetration of risk and return concept will become more important. The Group's consolidated ESR is at a sufficient level to maintain soundness even under considerable stress.

### A) Business Bases

The likelihood of a given debt payment is highly conditional to its issuer's business bases - how they can be maintained/ expanded into the future and thereby secure earnings and cash flows in adequacy and in a sustainable way.

#### B) Financial Grounds and Asset Quality

The likelihood of debt payment is highly dependent on the degree of the issuer's indebtedness and loss absorption capacity in terms of equity capital. Also notable is that a financial institution might see a significant loss of financial grounds as a result of changes in value of the assets under its possession.



### C) Liquidity Positions

The likelihood of debt payment is highly dependent on the adequacy of the issuer's cash and other sources of repayment (liquidity positions).

D) Related Parties' Status and Stance of Support/ Assistance for the Issuer

The likelihood of debt payment is affected one way or the other by the issuer's related parties such as parent company, subsidiary, guarantor, and the government of the issuer's business domicile, etc. - by their own conditions and/ or position of support/ assistance for the issuer.

### E) Order of Seniority in Debt Payment

The likelihood of debt payment can be different between given debts of the same issuer. The likelihood of debt payment for an individual debt is dependent on the issuer's discretion, and/ or its rank relative to other debts of the same issuer in the order of seniority in principal/ interest payment which is determined by design as financial product or by laws, etc.

# 11 Explanation or Measure of the Potential Volatility of the Credit Rating as Required by Paragraph (a)(1)(ii)(K) of Rule 17g-7

#### A) Business Bases

The credit rating is subject to alteration if there is improvement or deterioration of the issuer's business bases, since its revenue, etc. may improve or deteriorate by the change in its business management policies, clients' preferences, competitive situation, or a technological innovation. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change in the business bases is large.

### B) Financial Grounds and Asset Quality

The credit rating is subject to alteration if the issuer increases/ decreases its debt/ capital or vice versa and thereby makes its individual debt payment liability less or more bearable and its loss absorption capacity into the future decreased or increased. Also, the changes in the quality of asset under the issuer's holding may affect the credit rating, since such changes could raise or lower the likelihood of future loss of the issuer's financial grounds. The resultant alteration of the credit rating is usually by a



notch, with possibility of a few notches if and when the change in the financial grounds and/ or asset quality is large.

### C) Liquidity Positions

The credit rating is subject to alteration if there is a change in the issuer's financial management policy or in the relations with fund procurement sources and the change thereby makes its liquidity positions improve or deteriorate. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is large.

- D) Related Parties' Status and Stance of Support/ Assistance for the Issuer
  - The credit rating is subject to alteration if there is a change in the issuer's parent company or subsidiary, guarantor or other provider of credit enhancement, or the government of the issuer's business domicile, or other related parties' own conditions and/ or position of support/ assistance for the issuer, and the change thereby makes its business bases, financial grounds and/ or liquidity positions improve or deteriorate, and/ or making the effectiveness of guarantee and other credit enhancement improve or deteriorate. The resultant alteration of the credit rating is usually a notch, with possibility of a few notches if and when the change is large.
- E) Order of Seniority in Debt Payment and Non-Payment Forgiven by Contract

  The credit rating is subject to alteration if there is a change in the rated debt's status in the order of seniority relative to other debts caused by the improvement/ deterioration of the issuer's financial condition. The resultant alteration of the credit rating is usually a notch, with possibility of a few notches if and when the change is large. Also, in case of the financial products for which non-payment of interest/ principal is contractually permissible, the credit rating is subject to alteration if and when

the likelihood of such non-payment is projected to increase or decrease. The resultant alteration of the

credit rating could be by a notch but often as much as a few notches.

F) Rise and Fall in General Economy and Markets

The credit rating is subject to alteration if there is a rise/ fall in the general economy and/ or the markets inducing the issuer's revenues/ expenses to increase/ decrease and vice versa, etc. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is exceptionally large.

#### G) Various Events

#### A) Business Bases

The credit rating herewith presented could be changed if and when the assumptions made at the time of its determination turn out to be inaccurate with regard to the issuer's business bases and powers of earning or cash flow generation, etc. The resultant change of the credit rating is most likely by a notch, as JCR speculates, but possibly as much as a few notches if the development is rapid in improvement or deterioration of the issuer's business bases on some drastic change in the operational environments, etc.

### C) Liquidity Risks

The credit rating herewith presented could be changed if and when the assumptions made at the time of its determination turn out to be inaccurate with regard to the issuer's liquidity positions. The resultant change of the credit rating is most likely by a notch, as JCR speculates, but possibly as much as a few notches if the development is rapid in improvement or deterioration of the issuer's liquidity positions on some drastic change in its financial management policy or relations with fund procurement sources, etc.

### D) Related Parties' Status and Stance of Support/ Assistance for the Issuer

The credit rating herewith presented could be changed if and when the assumptions made at the time of its determination turn out to be inaccurate with regard to the issuer's parent company or subsidiaries, guarantor or other providers of credit enhancement, the government of the issuer's business domicile or other related parties' status and stance of support/ assistance for the issuer. The resultant change of the credit rating is most likely by a notch, as JCR speculates, but possibly as much as a few notches if there is a major change on the part of related parties, such as replacement, disappearance, some drastic improvement/ deterioration of financial grounds/ balances, etc.

### E) Rise and Fall in General Economy and Markets

The credit rating herewith presented could be changed if and when the assumptions made at the time of its determination turn out to be inaccurate with regard to the prospects of general economy and markets. JCR expects the change should be most likely by a notch but could be as much as a few notches, should the economy or the markets change so greatly.
