Japan Credit Rating Agency, Ltd. (JCR) announces the following credit rating.

### Sekisui House Reit, Inc. (security code: 3309)

<Affirmation>

Long-term Issuer Rating: AA
Outlook: Stable
Bonds: AA

#### Rationale

- (1) Sekisui House Reit, Inc. ("SHR") is a diversified J-REIT. It pursues external growth through the sponsor support agreement with Sekisui House, Ltd. (the "Sponsor") and the preferential negotiation right agreement with Sekisui House Real Estate companies, and also internal growth by leveraging collective capabilities of the Sekisui House Group. The portfolio currently consists of 131 properties with the asset size of 551.6 billion yen. By asset type based on the acquisition price, it is accounted for 55.2% by residences, 41.7% by office buildings and 3.1% by hotels.
- (2) In December 2023, SHR announced changes in the portfolio construction policy and transformed the portfolio mainly consisting of residences where the Sponsor's strength lies. SHR has made decisions to transfer Gotenyama SH Building over 10 fiscal periods from the fiscal period ended October 31, 2023, Garden City Shinagawa Gotenyama and Hommachi Garden City (office building portion and hotel portion) from the fiscal period ending April 30, 2024 toward the fiscal period ending April 30, 2025. On the other hand, SHR acquired one office building from an external party and ten residences mainly ones developed by the Sponsor. Through the asset shuffle this time, the portfolio size is expected to shrink to 414.2 billion yen. That said, the Sponsor's support system heading toward maintaining and increasing competitiveness of the portfolio remains unchanged. JCR assumes that SHR will continue to acquire sponsor-developed high-quality residences. On the financial front, sound financial management is continued as shown by the details of interest-bearing debt financing, LTV being controlled in consideration of financial stability, etc. Based on the above, JCR affirmed the ratings on SHR with Stable outlook.
- (3) As at the end of the fiscal period ended October 31, 2023, the occupancy rates were as follows: 96.7% for the entire portfolio; 97.3% for residences; and 94.4 for office buildings. For the residences, occupancy rates for those for single-person type, small type and family type are all remained at high levels and the rent fluctuation ratio at the time of concluding new contract was the highest ever, at 4.2%. The occupancy rate of entire office buildings is expected to recover because of transferring Garden City Shinagawa Gotenyama and progress in finding new tenants for the vacant slots in Akasaka Garden City where multiple tenants moved out. Going forward, JCR will watch the progress status in replacement strategies of the properties in the portfolio, which SHR is pushing ahead now, quality of properties to be acquired and the liquidity, and also the trend in cash flow.
- (4) As for fund procurement, SHR has established a solid bank formation centering on the Sponsor's main banks. SHR's resilience against risk of rising interest rates is relatively high given the ratios of long-term debt and fixed interest rate debt in total interest-bearing liabilities of 98.8% and 93.3% respectively as at the end of the fiscal period ended October 31, 2023, staggered repayment dates and others. In response to changes in the operation guidelines, total asset-based LTV under the normal circumstances has been changed to between 45% and 50% as a benchmark from the middle of 40% range in the past, but any significant change was not recognized as indicated that total asset-based LTV as at the end of the fiscal period ended October 31, 2023 was standing 45.2% remained unchanged from a year earlier. Unrealized gain ratio serving as a financial buffer declined due to disposing of properties and decline in appraisal value of Garden City Shinagawa Gotenyama, but it was still sufficient at 18.2% at the end of the fiscal period ending October 31, 2023. Thereby JCR views there are no particular concerns over SHR's financial position at present.

#### B) Financial Grounds and Asset Quality

The likelihood of debt payment is highly dependent on the degree of the issuer's indebtedness and loss absorption capacity in terms of equity capital. Also notable is that a J-REIT might see a significant loss of financial grounds as a result of changes in value of the assets under its possession.

#### C) Liquidity Positions

The likelihood of debt payment is highly dependent on the adequacy of the issuer's cash and other sources of repayment (liquidity positions) including certainty of refinancing.



- D) Related Parties' Status and Stance of Support/ Assistance for the Issuer

  The likelihood of debt payment is affected one way or the other by the issuer's related parties such as sponsor, asset manager, guarantor, and the government of the issuer's business domicile, etc. by their own conditions and/ or position of support/ assistance for the issuer.
- E) Order of Seniority in Debt Payment

  The likelihood of debt payment can be different between given debts of the same issuer. The

#### A) Portfolios

The credit rating is subject to alteration if there is improvement or deterioration of quality, competitive strength and diversification in the issuer's portfolios, since its revenue, etc. may improve or deteriorate by the change in its investment strategies, tenants' preferences, competitive situation, or a technological innovation. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change in the portfolios is large.

#### B) Financial Grounds and Asset Quality

The credit rating is subject to alteration if the issuer increases/ decreases its debt/ capital or vice versa and thereby makes its individual debt payment liability less or more bearable and its loss absorption capacity into the future decreased or increased. Also, the changes in the quality of asset under the issuer's holding may affect the credit rating, since such changes could raise or lower the likelihood of future loss of the issuer's financial grounds. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change in the financial grounds and/ or asset quality is large.

#### C) Liquidity Positions

The credit rating is subject to alteration if there is a change in the issuer's financial management policy or in the relations with fund procurement sources and the change thereby makes its liquidity positions improve or deteriorate. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is large.



#### D) Related Parties' Status and Stance of Support/ Assistance for the Issuer

The credit rating is subject to alteration if there is a change in the issuer's sponsor or asset manager, guarantor or other provider of credit enhancement, or the government of the issuer's business domicile, or other related parties' own conditions and/ or position of support/ assistance for the issuer, and the change thereby makes its portfolios, financial grounds and/ or liquidity positions improve or deteriorate, and/ or making the effectiveness of guarantee and other credit enhancement improve or deteriorate.
