Japan Credit Rating Agency, Ltd. (JCR) announces the following credit rating.

TOKYU CORPORATION (security code: 9005)

Rationale

- (1) TOKYU CORPORATION (the "Company") is the core company of the Tokyu Group. The railways centered on the Den-en-toshi Line and the Toyoko Line are popular as commuting lines and their mutual operations with other railway companies' lines are well developed. In addition to the transportation business centered on railways, the Company operates a variety of businesses including the real estate business (sales, lease, management, etc.), the life services business (department stores, stores, ICT media, etc.), and the hotel & resort business. In January 2023, Tokyu Kabukicho Tower was completed. In March 2023, the Tokyu Shin-Yokohama Line (Hiyoshi Station to Shin-Yokohama Station) opened and railway fares were revised.
- (2) Although the transportation business and hotel & resort business were strongly affected by the COVID-19 pandemic, the earnings structure has been strengthened through the progress of structural reforms and the contribution of railway fare revisions. In addition, Shibuya Scramble Square (East Building) and Minami-machida Granberry Park, which were completed just before the pandemic, began contributing to earnings in earnest, raising the level of EBITDA. Although construction work on Shibuya Scramble Square (Center and West Buildings) is expected to progress going forward, large investments have peaked out. Given also the fact that EBITDA is expected to remain at a high level, the possibility increased that Company will continue to strengthen its financial position. Based on the above, JCR has affirmed the ratings on the Company but changed the outlook to Positive.
- (3) Operating profit for the fiscal year ending March 2024 (FY2023) is planned to reach a new record high of 85 billion yen (up 90.6% year on year). This is expected to be contributed by a recovery in the number of railway and bus passengers, the effects of railway fare revisions, improvements in hotel occupancy rates and average daily rates, and an increase in the number of condominium units sold. Although there may be a reactionary decline in condominium sales in the future, JCR believes that the Company will be able to secure high levels of operating profit and EBITDA mainly in the transportation and real estate businesses. Efforts to improve efficiency are also making steady progress, such as the transition to one-person operation on the Toyoko Line completed in October 2023.
- (4) The interest-bearing debt/EBITDA ratio (the Company's published value) for FY2022 was 8.9x, improving for the second consecutive period from the most recent bottom of 15.8x in FY2020. It is planned to improve to 6.6x in FY2023. Going forward, redevelopment projects are planned in Shibuya, including Shibuya Upper West Project, Shibuya Scramble Square (Center and West Buildings), and areas along the railway lines. However, JCR believes that the number of large development projects peaked out with the completion of Shibuya Scramble Square (East Building). Considering the Company's increasing cash flow generation capacity, its financial indicators are highly likely to continue to improve.

The likelihood of a given debt payment is highly conditional to its issuer's business bases - how they can be maintained/ expanded into the future and thereby secure earnings and cash flows in adequacy and in a sustainable way.

B) Financial Grounds and Asset Quality

The likelihood of debt payment is highly dependent on the degree of the issuer's indebtedness and loss absorption capacity in terms of equity capital. Also notable is that a financial institution might see a significant loss of financial grounds as a result of changes in value of the assets under its possession.

C) Liquidity Positions

The likelihood of debt payment is highly dependent on the adequacy of the issuer's cash and other sources of repayment (liquidity positions).



- D) Related Parties' Status and Stance of Support/ Assistance for the Issuer

 The likelihood of debt payment is affected one way or the other by the issuer's related parties such as parent company, subsidiary, guarantor, and the government of the issuer's business domicile, etc. by their own conditions and/ or position of support/ assistance for the issuer.
- E) Order of Seniority in Debt Payment

 The likelihood of debt payment can be different between given debts of the same issuer. The likelihood of debt payment for an individual debt is dependent on the issuer's discretion, and/ or its rank relative to other debts of the same issuer in the order of seniority in principal/ interest payment which is determined by design as financial product or by laws, etc.

A) Business Bases

The credit rating is subject to alteration if there is improvement or deterioration of the issuer's business bases, since its revenue, etc. may improve or deteriorate by the change in its business management policies, clients' preferences, competitive situation, or a technological innovation. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change in the business bases is large.

B) Financial Grounds and Asset Quality

The credit rating is subject to alteration if the issuer increases/ decreases its debt/ capital or vice versa and thereby makes its individual debt payment liability less or more bearable and its loss absorption capacity into the future decreased or increased. Also, the changes in the quality of asset under the issuer's holding may affect the credit rating, since such changes could raise or lower the likelihood of future loss of the issuer's financial grounds. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change in the financial grounds and/ or asset quality is large.

C) Liquidity Positions

The credit rating is subject to alteration if there is a change in the issuer's financial management policy or in the relations with fund procurement sources and the change thereby makes its liquidity positions improve or deteriorate. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is large.



D) Related Parties' Status and Stance of Support/ Assistance for the Issuer

The credit rating is subject to alteration if there is a change in the issuer's parent company or subsidiary, guarantor or other provider of credit enhancement, or the government of the issuer's business domicile, or other related parties' own conditions and/ or position of support/ assistance for the issuer, and the change thereby makes its business bases, financial grounds and/ or liquidity positions improve or deteriorate, and/ or making the effectiveness of guarantee and other credit enhancement improve or deteriorate. The resultant alteration of the credit rating is usually a notch, with possibility of a few notches if and when the change is large.

E) Order of Seniority in Debt Payment and Non-Payment Forgiven by Contract

The credit rating is subject to alteration if there is a change in the rated debt's status in the order of seniority relative to other debts caused by the improvement/ deterioration of the issuer's financial condition. The resultant alteration of the credit rating is usually a notch, with possibility of a few notches if and when the change is large. Also, in case of the financial products for which non-payment of interest/ principal is contractually permissible, the credit rating is subject to alteration if and when the likelihood of such non-payment is projected to increase or decrease. The resultant alteration of the credit rating could be by a notch but often as much as a few notches.

F) Rise and Fall in General Economy and Markets

The credit rating is subject to alteration if there is a rise/ fall in the general economy and/ or the markets inducing the issuer's revenues/ expenses to increase/ decrease and vice versa, etc. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is exceptionally large.

G) Various Events

The credit rating is subject to alteration on occurrence of various events, such as change in the issuer's major shareholders, M&A and other organizational change, accident, violation of the law, litigation, legal/ regulatory change, natural disaster, etc., which are unforeseeable at the time when the credit rating is determined, causing a significant change on the issuer's business bases, financial grounds, etc. The resultant alteration of the credit rating could be by a notch but more often than not as much as a few notches.

A) Business Bases

The credit rating herewith presented could be changed if and when the assumptions made at the time of its determination turn out to be inaccurate with regard to the issuer's business bases and powers of earning or cash flow generation, etc. The resultant change of the credit rating is most likely by a notch, as JCR speculates, but possibly as much as a few notches if the development is rapid in improvement or deterioration of the issuer's business bases on some drastic change in the operational environments, etc.

B) Financial Grounds and Asset Quality

C) Liquidity Risks

The credit rating herewith presented could be changed if and when the assumptions made at the time of its determination turn out to be inaccurate with regard to the issuer's liquidity positions. The resultant change of the credit rating is most likely by a notch, as JCR speculates, but possibly as much as a few notches if the development is rapid in improvement or deterioration of the issuer's liquidity positions on some drastic change in its financial management policy or relations with fund procurement sources, etc.

- D) Order of Seniority in Debt Payment and Non-Payment Forgiven by Contract
 - The credit rating herewith presented could be changed if and when the assumptions made at the time of its determination turn out to be inaccurate with regard to the order of seniority in repayment of interests and principal. JCR assumes the resultant change of the credit rating is most likely by a notch. The change could be as much as a few notches if the issuer's financial structure differs so much and thereby the balance between debts shifted so greatly. Rating change is also possible in case of the financial products for which non-payment of interest/ principal is contractually permissible, if and when the assumptions made at the time of its determination turns out to be inaccurate. The change of the credit rating is assumed to be by a notch but often as much as a few notches.
- E) Rise and Fall in General Economy and Markets

The credit rating herewith presented could be changed if and when the assumptions made at the time of its determination turn out to be inaccurate with regard to the prospects of general economy and markets. JCR expects the change should be most likely by a notch but could be as much as a few notches, should the economy or the markets change so greatly.
