Rationale

Issuer: Bank of The Ryukyus, Limited

- (1) Bank of The Ryukyus, Limited (the "Bank") is a regional bank headquartered in Naha City, Okinawa Prefecture with a fund volume of around 2 trillion yen. It holds a high market share of about 35% in the prefecture for loans. Okinawa's economy has been steadily growing in recent years, led by tourism-related industry. Backed by strong needs for housing against the backdrop of the rising population and number of households as well, the Bank's housing loans and loans to real estate leasing industry have been highly growing. JCR reflects in the Bank's rating the facts including its solid business base in Okinawa Prefecture where the operating market conditions are favorable and relatively sound loan asset quality.
- (2) The Bank's ROA (based on substantive core net business income excluding gains (losses) on cancellation of investment trusts, etc.), standing at around 0.3%, is slightly below the average of regional banks. The substantive core net business income has been more than 20% lower as compared with that income in and before the fiscal year ended March 2016 (FY2015). This is mainly because lowered yield on loans due to introduction of negative interest rate policy and increased expenses due to prior investments in card business. Going forward, there is a possibility that the expenses will increase along with the improvement of sales system and drop of interest and dividend on securities will expand. The Bank, on the other hand, achieved good results in its focusing payment settlement business and enhancement of corporate fee business. The interest on loans and discounts which constitutes core of its revenue has been declining, but the revenue is increasing thanks to the increased loans to real estate leasing industry and loans based on business evaluation. Given this trend, JCR sees that its core net business income will remain solid over a medium term, even though that income may temporarily weaken. For loans to the real estate leasing industry, the Bank is strengthening its efforts than before to focus on quality of the transactions. JCR sees that whether the Bank can retain the increasing trend of loans and the relatively high yield will be a key point for the prospect for future business performance.
- (3) Balance of domestic bonds in the securities investment has been declining due to continued low interest rate. The Bank has been flexibly increasing and decreasing balance of foreign currency denominated foreign bonds, but is now making efforts to reduce exposures to such bonds. Thanks to this effort, its interest rate risk amount is controlled against capital. Despite the small amount of unrealized gains on securities, amount of price fluctuation risk from equity securities is controlled against capital.
- (4) The Bank's non-performing loans ratio disclosed under the Financial Reconstruction Act stands at a low level of around 1.5%. Thanks partly to reversal of conservative allowance for bad loans which was set aside in the past, its credit costs are limited to a small amount. JCR sees that its

credit costs will remain stable for the time being, given partly the few assets requiring caution which are not covered by loan loss reserve, collateral, guarantees or other means for the larger part. It is necessary to watch that ratio of loans to real estate industry to the total loans is high. Given that majority of such loans are loans concerning residential leasing properties and that such loans are diversified into small accounts as well as population movement in Okinawa, however, JCR sees that the impact on the credit costs will be limited.

- (5) As of September 30, 2018, the consolidated core capital ratio stood at 9.65% and this ratio adjusted for eligible Tier 2 capital instruments subject to phase-out arrangements, allowance for loan losses, etc. is also at a good level as compared with regional banks with a credit rating of A. Although there is a pressure to increase the risk assets along with the increase of loan balance, the Bank has been making efforts to maintain and improve the core capital ratio by capital enhancement through capital increase.

Issuer: Okinawa Credit Service Co., Ltd.

- (1) Okinawa Credit Service Co., Ltd. (the "Company") is a credit sales company that was established in August 2008 to take over business of OCS, which is the first credit sales company in Okinawa, and became a wholly-owned subsidiary of the Bank in April 2015. It operates credit card, shopping credit (installment credit sales) centering on auto loans, loans, credit guarantees as its main businesses, and has expanded its new businesses such as electronic money and processing in recent years. JCR reflects in the Company's rating the facts including factors that it can receive material and immaterial support from the Bank, based on the very strong relationships with the Bank in terms of capital, financing and sales as a core subsidiary assuming card business in the Bank's Group and that it has relatively good capital level.
- (2) The operating income for the first half of FY2018 resulted in a loss of 30 million yen (decrease by 110 million yen from that income during the same period a year ago). Further increase of expenses along with IC cards for the credit card had a significant impact on the income in a situation where the non-personnel expenses have been staying at a high level due partly to the shift to the new system. For the IC credit cards, the Company has already recorded majority of the expenses for the issue and deliveries of those cards in the first half of FY2018, and the impact on the profit is mostly temporary. The growth of operating revenue has been stagnant due to the decreasing cashing balance, although revenue from new businesses such as electronic money has increased and increasing balance of auto loans has helped increase the revenue. JCR is paying attention to whether the Company can support the revenue through an increase of card members in cooperation with the Bank and expansion of revenue from new businesses. It retains the quality of operating receivables in general and the credit costs have been staying at a level that is roughly equal to the level a year ago.
- (3) As of September 30, 2018, its equity ratio stood at 26.2%, which is much higher than those of major credit sales companies. As the gains on reversal of investment in silent partnership, which have been leading the recent improvement of equity ratio, finished in FY2017, a significant improvement of financial structure cannot be expected easily going forward. Its financing is covered by indirect financing from the Bank and is stable.

Issuer: Ryukyu Leasing Co., Ltd.

- (1) Ryukyu Leasing Co., Ltd. (the "Company") is a general leasing company, which is affiliated with the Bank. It became a consolidated subsidiary in April 2014 and then a wholly-owned subsidiary of the Bank in July 2017. Featuring a high composition ratio of auto lease by equipment type, it has a large market share in Okinawa. JCR reflects in the Company's rating the facts including factors that it can receive material and immaterial support from the Bank, based on the strong relationships with the Bank in terms of capital and financing as a subsidiary playing an important role in the Bank Group's corporate strategy and that it has relatively good capital level as compared with large leasing companies.
- (2) The operating income for the first half of FY2018 decreased by 30 million yen from the same period a year ago to 0.24 billion yen. While reduction of interest expenses supported the income, lease gross profit declined due mainly to lowered yield as well as reactionary fall from the temporary recording of gains on lease cancellation during the same period a year ago had a significant impact on the income. For the transaction amounts of lease and installment, that of auto lease centering on auto lease for rent-a-car is strong. Against the backdrop of strong demand for construction, lease for construction machinery is also growing. The strengthened cooperation with the Bank has gradually increased transactions that were introduced by the Bank. Pressure to

decrease yield centering on transactions with major users has been strong. JCR will closely watch whether the Company can offset impact from the lowered yield by an increase of assets as well as impact from competition. It retains the quality of operating receivables in general and the credit costs have been staying at a level that is roughly equal to the level a year ago.

- (3) As of September 30, 2018, its equity ratio stood at 13.9%, which is good level as compared with major lease companies. While its retained earnings have been steadily accumulating on the strength of firm business performance, assets are increasing. Although there is a possibility that the increasing assets may put a downward pressure on the equity ratio, JCR sees that the impact on the financial assessment will be limited. Given the indirect financing from the Banks as the main tool for the financing, JCR sees that the Company will be able to keep the stable financing going forward.

3 The Main Assumptions and Principles used in Constructing the Procedures and Methodologies used to Determine the Credit Rating as Required by Paragraph (a)(1)(ii)(C) of Rule 17g-7

- The credit rating methodology assumes, in principle, to be applied to assess the likelihood of a given debt payment in light of its issuer's condition and business environment, etc. in the relevant future. There is certain limitation, however, in the time horizon that the rating foresees.
- The credit rating methodology assumes, in principle, that the factors posted in the below are particularly important for such likelihood to be determined, and that the rating determination is made by evaluating each of them not only quantitatively but also employing qualitative analyses.

A) Business Bases

The likelihood of a given debt payment is highly conditional to its issuer's business bases - how they can be maintained/ expanded into the future and thereby secure earnings and cash flows in adequacy and in a sustainable way.

B) Financial Grounds and Asset Quality

The likelihood of debt payment is highly dependent on the degree of the issuer's indebtedness and loss absorption capacity in terms of equity capital. Also notable is that a financial institution might see a significant loss of financial grounds as a result of changes in value of the assets under its possession.

C) Liquidity Positions

The likelihood of debt payment is highly dependent on the adequacy of the issuer's cash and other sources of repayment (liquidity positions).

D) Related Parties' Status and Stance of Support/ Assistance for the Issuer

The likelihood of debt payment is affected one way or the other by the issuer's related parties such as parent company, subsidiary, guarantor, and the government of the issuer's business domicile, etc. - by their own conditions and/ or position of support/ assistance for the issuer.

E) Order of Seniority in Debt Payment

The likelihood of debt payment can be different between given debts of the same issuer. The likelihood of debt payment for an individual debt is dependent on the issuer's discretion, and/ or its rank relative to other debts of the same issuer in the order of seniority in principal/ interest payment which is determined by design as financial product or by laws, etc.

A) Business Bases

The credit rating is subject to alteration if there is improvement or deterioration of the issuer's business bases, since its revenue, etc. may improve or deteriorate by the change in its business management policies, clients' preferences, competitive situation, or a technological innovation. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change in the business bases is large.

B) Financial Grounds and Asset Quality

The credit rating is subject to alteration if the issuer increases/ decreases its debt/ capital or vice versa and thereby makes its individual debt payment liability less or more bearable and its loss absorption capacity into the future decreased or increased. Also, the changes in the quality of asset under the issuer's holding may affect the credit rating, since such changes could raise or lower the likelihood of future loss of the issuer's financial grounds. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change in the financial grounds and/ or asset quality is large.

C) Liquidity Positions

The credit rating is subject to alteration if there is a change in the issuer's financial management policy or in the relations with fund procurement sources and the change thereby makes its liquidity positions improve or deteriorate. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is large.

D) Related Parties' Status and Stance of Support/ Assistance for the Issuer

The credit rating is subject to alteration if there is a change in the issuer's parent company or subsidiary, guarantor or other provider of credit enhancement, or the government of the issuer's

business domicile, or other related parties' own conditions and/ or position of support/ assistance for the issuer, and the change thereby makes its business bases, financial grounds and/ or liquidity positions improve or deteriorate, and/ or making the effectiveness of guarantee and other credit enhancement improve or deteriorate. The resultant alteration of the credit rating is usually a notch, with possibility of a few notches if and when the change is large.

E) Order of Seniority in Debt Payment and Non-Payment Forgiven by Contract

The credit rating is subject to alteration if there is a change in the rated debt's status in the order of seniority relative to other debts caused by the improvement/ deterioration of the issuer's financial condition. The resultant alteration of the credit rating is usually a notch, with possibility of a few notches if and when the change is large. Also, in case of the financial products for which non-payment of interest/ principal is contractually permissible, the credit rating is subject to alteration if and when the likelihood of such non-payment is projected to increase or decrease. The resultant alteration of the credit rating could be by a notch but often as much as a few notches.

F) Rise and Fall in General Economy and Markets

The credit rating is subject to alteration if there is a rise/ fall in the general economy and/ or the markets inducing the issuer's revenues/ expenses to increase/ decrease and vice versa, etc. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is exceptionally large.

G) Various Events

The credit rating is subject to alteration on occurrence of various events, such as change in the issuer's major shareholders, M&A and other organizational change, accident, violation of the law, litigation, legal/ regulatory change, natural disaster, etc., which are unforeseeable at the time when the credit rating is determined, causing a significant change on the issuer's business bases, financial grounds, etc. The resultant alteration of the credit rating could be by a notch but more often than not as much as a few notches.

C) Liquidity Risks

The credit rating herewith presented could be changed if and when the assumptions made at the time of its determination turn out to be inaccurate with regard to the issuer's liquidity positions. The resultant change of the credit rating is most likely by a notch, as JCR speculates, but possibly as much as a few notches if the development is rapid in improvement or deterioration of the issuer's liquidity positions on some drastic change in its financial management policy or relations with fund procurement sources, etc.

D) Related Parties' Status and Stance of Support/ Assistance for the Issuer

The credit rating herewith presented could be changed if and when the assumptions made at the time of its determination turn out to be inaccurate with regard to the issuer's parent company or subsidiaries, guarantor or other providers of credit enhancement, the government of the issuer's business domicile or other related parties' status and stance of support/ assistance for the issuer. The resultant change of the credit rating is most likely by a notch, as JCR speculates, but possibly as much as a few notches if there is a major change on the part of related parties, such as replacement, disappearance, some drastic improvement/ deterioration of financial grounds/ balances, etc.

E) Rise and Fall in General Economy and Markets

The credit rating herewith presented could be changed if and when the assumptions made at the time of its determination turn out to be inaccurate with regard to the prospects of general economy and markets. JCR expects the change should be most likely by a notch but could be as much as a few notches, should the economy or the markets change so greatly.

JCR expects the change should be most likely by a notch but could be as much as a few notches, should the economy or the markets change so greatly.
