Japan Credit Rating Agency, Ltd. (JCR) announces the following credit rating.

### Frontier Real Estate Investment Corporation (security code: 8964)

<Affirmation>

Long-term Issuer Rating: AA
Outlook: Stable
Bonds: AA

#### Rationale

- (1) Frontier Real Estate Investment Corporation ("FRI") is a J-REIT specializing in retail facilities. The shareholder of its asset manager Mitsui Fudosan Frontier REIT Management Inc. ("MFR") is Mitsui Fudosan Co., Ltd. (the "Sponsor"), which develops and operates wide-ranging retail facilities including urban retail facilities and outlet malls. The Sponsor's know-how related to retail facilities is utilized for the stable operation of retail facilities by FRI, and MFR continues to make efforts to maintain/improve the competitiveness of the facilities. FRI's portfolio consists of 41 diverse retail facilities, with a total acquisition price of 364.7 billion yen, building a highly competitiveness portfolio.
- (2) FRI will continue to acquire high-quality properties by utilizing its sponsor pipeline. In March 2025 it plans to acquire Mitsui Shopping Park LaLaport AlCHI TOGO, a large shopping center ("SC") developed/operated by the Sponsor, which has enjoyed robust sales since its opening. In addition, while acquiring two properties (Yaoko Sagamihara Hikarigaoka store, Yaoko Nishiomiya store) worth 4.5 billion yen from a third party, FRI sold to a third party a property (Queens Isetan Suginami Momoi store), which is relatively old and its future profitability will likely be limited due to changes in the competitive environment in the neighborhood, while efforts to improve portfolio quality are underway. Additionally, as indicated by master lease agreements and SC management agreements established with the Sponsor for ensuring stable cash flows, FRI is enjoying the Sponsor's support in terms of internal growth. Regarding finances, FRI continues prudent financial management, with LTV controlled at a conservative level. There has been no change in the strong support structure from the Sponsor, and stable portfolio management is expected to continue for the time being. Based on the above, JCR has affirmed the ratings on FRI with Stable outlook.
- (3) Overall portfolio management remains relatively stable, thanks to the diversification effect of asset categories. The occupancy rate of the entire portfolio (on an end-tenant basis) remained at a high level of 100.0% as of the end of December 2024. Contract renewals with tenants are progressing smoothly overall, and rent increases have been achieved. The average contract period for leasing contracts is 20.6 years, with a fixed rent ratio of 99.2%, ensuring a stable revenue foundation based on long-term fixed rents that are less susceptible to the direct effects of economic fluctuations. On the other hand, in the current inflationary environment, attention is paid to the realization of rent increase. JCR will keep watching MFR's efforts for internal growth, the impact of the expansion of ecommerce on actual stores, and MFR's leasing strategies such as tenant mix.
- (4) As shown by the LTV including security and guarantee deposits at 44.6% as of the end of December 2024 (45.1% a year earlier), stable leverage control is being continued. The ratio of unrealized gains of 32.3% as of the same date indicates a sufficient financial buffer. Debt repayment dates have been staggered, and, with a high ratio of long-term fixed-rate interest-bearing debts, reasonable tolerance to rising interest rates is ensured. FRI intends to maintain conservative financial management by leveraging the Sponsor's creditworthiness going forward, and given its good business relations with financial institutions and a solid financial base, there are no particular concerns for the current financial position, in JCR's judgement.

#### A) Portfolios

The likelihood of a given debt payment is highly conditional to its issuer's portfolios - how they can be maintained/enhanced into the future and thereby secure earnings and cash flows in adequacy and in a sustainable way.

- B) Financial Grounds and Asset Quality
  - The likelihood of debt payment is highly dependent on the degree of the issuer's indebtedness and loss absorption capacity in terms of equity capital. Also notable is that a J-REIT might see a significant loss of financial grounds as a result of changes in value of the assets under its possession.
- C) Liquidity Positions
  - The likelihood of debt payment is highly dependent on the adequacy of the issuer's cash and other sources of repayment (liquidity positions) including certainty of refinancing.



- D) Related Parties' Status and Stance of Support/ Assistance for the Issuer

  The likelihood of debt payment is affected one way or the other by the issuer's related parties such as sponsor, asset manager, guarantor, and the government of the issuer's business domicile, etc. by their own conditions and/ or position of support/ assistance for the issuer.
- E) Order of Seniority in Debt Payment

  The likelihood of debt payment can be different between given debts of the same issuer. The likelihood of debt payment for an individual debt is dependent on the issuer's discretion, and/ or its rank relative to other debts of the same issuer in the order of seniority in principal/ interest payment which is determined by design as financial product or by laws, etc.

#### A) Portfolios

The credit rating is subject to alteration if there is improvement or deterioration of quality, competitive strength and diversification in the issuer's portfolios, since its revenue, etc. may improve or deteriorate by the change in its investment strategies, tenants' preferences, competitive situation, or a technological innovation. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change in the portfolios is large.

#### B) Financial Grounds and Asset Quality

The credit rating is subject to alteration if the issuer increases/ decreases its debt/ capital or vice versa and thereby makes its individual debt payment liability less or more bearable and its loss absorption capacity into the future decreased or increased. Also, the changes in the quality of asset under the issuer's holding may affect the credit rating, since such changes could raise or lower the likelihood of future loss of the issuer's financial grounds. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change in the financial grounds and/ or asset quality is large.

#### C) Liquidity Positions

The credit rating is subject to alteration if there is a change in the issuer's financial management policy or in the relations with fund procurement sources and the change thereby makes its liquidity positions improve or deteriorate. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is large.



#### D) Related Parties' Status and Stance of Support/ Assistance for the Issuer

The credit rating is subject to alteration if there is a change in the issuer's sponsor or asset manager, guarantor or other provider of credit enhancement, or the government of the issuer's business domicile, or other related parties' own conditions and/ or position of support/ assistance for the issuer, and the change thereby makes its portfolios, financial grounds and/ or liquidity positions improve or deteriorate, and/ or making the effectiveness of guarantee and other credit enhancement improve or deteriorate. The resultant alteration of the credit rating is usually a notch, with possibility of a few notches if and when the change is large.

#### E) Order of Seniority in Debt Payment and Non-Payment Forgiven by Contract

The credit rating is subject to alteration if there is a change in the rated debt's status in the order of seniority relative to other debts caused by the improvement/ deterioration of the issuer's financial condition. The resultant alteration of the credit rating is usually a notch, with possibility of a few notches if and when the change is large. Also, in case of the financial products for which non-payment of interest/ principal is contractually permissible, the credit rating is subject to alteration if and when the likelihood of such non-payment is projected to increase or decrease. The resultant alteration of the credit rating could be by a notch but often as much as a few notches.

#### F) Rise and Fall in General Economy and Markets

The credit rating is subject to alteration if there is a rise/fall in the general economy and/ or the markets, of e.g. real estate or interest rates, inducing the issuer's revenues/ expenses to increase/decrease and vice versa, etc. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is exceptionally large.

#### G) Various Events

The credit rating herewith presented could be changed if and when the assumptions made at the time of its determination turn out to be inaccurate with regard to the issuer's sponsor or asset manager, guarantor or other providers of credit enhancement, the government of the issuer's business domicile or other related parties' status and stance of support/ assistance for the issuer. The resultant change of the credit rating is most likely by a notch, as JCR speculates, but possibly as much as a few notches if there is a major change on the part of related parties, such as replacement, disappearance, some drastic improvement/ deterioration of financial grounds/ balances, etc.
